HB 2810 - extending effective dates for regulations which exceed federal requirements.

Representative Farmer made a motion to pass HB 2810 favorably from committee. Representative O'Connor seconded. Motion carried.

HB 2594 - art work, displays and special events in state capitol.

Representative Dawson made a motion to pass HB 2594 from committee. Representative Majure seconded.

Representative Wootten made an amendment to require one of the Governor's appointments to the board be of ethnic or racial minority. Representative Mills seconded. After division was called the motion failed. Representative Mills is recorded as voting yes on the amendment.

Representative Dawson made a motion to amend HB 2594 to add "or Director of Legislative Administrative Services" on page 2 line 13. Representative Wootten seconded. The motion carried.

Representative Wootten made a motion to pass HB 2594 out of committee as amended. Representative Dawson seconded. Motion carried. Representative Gilbert is recorded as voting no.

HB 2760 - reorganization of department of commerce and housing.

Representative Dawson made a motion to pass favorably HB 2760. Representative Farmer seconded. Motion carried.

HB 2913 - establishing an elected office of state director of property evaluation.

Representative Bradley made a motion to pass favorably HB 2913. Representative Wells seconded. Upon call for division, motion carried.

HB 2901 - establishment of Kansas commission on the status of women.

Representative Macy made a motion to pass HB 2901 favorably from committee. Representative Ballard seconded. Motion carried.

HB 2719 - election campaign finance; fees to commission on governmental standards and conduct fee fund.

Representative Wells made a motion to pass favorably HB 2719. Representative Majure seconded.

A balloon amendment which would include only candidates who have a campaign treasurer was handed out.

Representative Macy made a motion to amend HB 2719 according to the balloon. Representative Farmer seconded. Motion carried.

Representative Macy made a motion to amend HB 2719 by changing the word shall on line 40, page 1 to may. Representative Dillon seconded. The motion carried.

Representative Macy made a motion to pass HB 2719 as amended. Representative Majure seconded. Motion carried.

HB 2730 - health care stabilization fund, transfer administration to board of governors from insurance commissioner.

Representative Hendrix made a motion to move HB 2730. Representative Bradley seconded.

Representative Hendrix made a motion to amend HB 2730 by giving the investment authority back to the Investment Pool rather than the board. Representative Wells seconded. Motion carried.

The Chair called for a vote on the bill as amended. HB 2730 was passed out as amended.

HB 2994 - land information board; land information program.

Representative Van Fleet moved to consider HB 2994. Representative Wootten seconded. After division was called for, motion carried.

HB 2543 - African-American advisory committee, composition, officers' powers and duties.

Representative Bradley made a motion to move HB 2543. Representative Ballard seconded.

Representative Wootten made a motion to amend the bill to change committee to commission. Motion carried.

Representative Macy made a motion to have the commission stand alone rather than under Human Resources. Representative Wootten seconded. After discussion with staff, Representative Macy withdrew her motion.

HB 2543 was passed from committee as amended.

HB 2745 - elections; enacting the election finance act.

Representative O'Connor made a motion to remove HB 2745 from the table. Representative Hendrix seconded. The motion failed.

The meeting was adjourned at 9:55 a.m. The next meeting is scheduled for unknown, 1994.
