Hearing on:

SB 655 - establishing the Kansas information resources council and the office of chief information architect.

Senator Todd Tiaht provided written testimony in support of SB 655, advising this is a portion of the Governor's efforts to reinvent government. The private sector has participated and invested their resources and that is part of why this bill is so significant. Senator Tiaht provided a balloon amendment that would reduce the council from 15 to 11 which would narrow the scope to the Administrative Branch of Kansas government, would narrow the scope of the bill to administrative policies, and would exclude the lottery, Board of Regents and Information Network of Kansas from the scope of this committee. Senator Tiaht also handed out a letter signed by all members of the Joint Committee on Computers and Tech-Communications (Attachment 1).

Representative George Dean appeared to give his support to SB 655 and amendments as offered by Senator Tiaht.

Susan Seltsam, Secretary of Administration, testified in support of SB 655 stating this bill would establish the Kansas Information Resources Council as a policy making body, which would facilitate the coordination of information technology standards, tools and methodologies and is the most positive way to bring about data coordination and sharing. It would also establish a chief information architect to be appointed by the Council and give the Council approval authority over planning and acquisition of equipment, programs, systems and maintenance. Secretary Seltsam proposed an amendment to review the effectiveness of the Council by a K-GOAL audit rather than abolishment on July 1, 1997 (Attachment 2).

Bill Jarrell, Kansas Government Affairs Manager of the Boeing Company, introduced Ron Terzian, Director of Operations, Boeing Computer Services in Wichita, who gave testimony in support of SB 655. Boeing Company was one of the private industries participants on reinventing Kansas Government and Mr. Terzian was team leader of the information management system team. Mr. Terzian provided written testimony in

information technology to the state's business. The initiatives derived from these issues form the basis of SB 655 (Attachment 3).

Ben Nelson, Chief of the Bureau of Computer Services, Department of Transportation, provided written testimony to support SB 655, which will allow Kansas to meet the challenges of the changing technology industry. This bill would establish an organization needed to manage the state's information technology (Attachment 4).

David Buhler, Information Network of Kansas, testified in support of SB 655 (Attachment 5). He stated they remain neutral on the policy decision of whether to enact this bill, however would recommend an amendment to the bill that would exempt Information Network of Kansas from SB 655. Mr. Buhler stated INK is a free-standing public instrumentality created by the Legislature, governed by a board of directors, one being the Director of DISC.

Pat Hurley, Information Network of Kansas, in response to a question reiterated that INK was created as a public entity and really is not a state agency as such and therefore should be exempt from SB 655.

John Bucher, Director of Computing and Network Services at Kansas State University, speaking for the computer advisory committee appeared in support of SB 655. Their concern had been for the removal of the exemption for the Board of Regents but they would now support SB 655 with the suggested amendment to exempt the Board of Regents from the bill. Mr. Bucher was in favor of the notion of a Users Council inasmuch as campuses have similar types of groups who advise them constantly.

Representative Gilbert made a motion to approve the minutes for the March 18, 1994 meeting as submitted. Representative Ballard seconded. The motion carried.

The meeting was adjourned at 10:00 a.m. The next meeting is scheduled for March 22, 1994.

SB 655 Testimony

House Governmental Organization Committee

Thank you Chairman Smith for the opportunity to testify in favor of SB 655.

I think this is a very important piece of legislation and I hope this committee will approve SB 655 with the amendments I am about to propose.

Before I explain the amendments I would like to say that this bill is a portion of the Governor's efforts to reinvent government. It has involved many hours and much effort from those in the state government as well as those from the private sector. This is the only bill that I know of that has come forward in relation to the task teams that worked on reinventing government.

It is also important, in my mind, that we have extended our hand to the private sector and asked them to become involved in improving the processes we use in conducting the business of state government. That is part of why this bill is so significant. The private sector has much to offer, the cutting edge of technology, the test bed for administrative policy, and the proof of what works. They have participated. They have invested their resources. If we ignore the efforts of our supporters in the private sector, I fear we will shut off or frustrate a wonderful resource, our Kansas private industries. So I encourage you to give this bill strong consideration.

As Vice Chairman of the Joint Committee on Computers and Tele-Communications (JCCT) I have been organizing support for SB 655. Originally this bill was past forward without recommendation by the JCCT. Subsequently, I have been in coordination with all members of the committee and we have worked out the committees concerns. The major concern was to focus this effort on the administrative branch of government. We have also taken into consideration the Speaker of the House's concern with the number of members on committees and of having members of the legislature participating in the Kansas information resources council.

I have had a balloon prepared to present the amendments, which I believe is an acceptable compromise. Basically, it does three things;

First, it reduces from 15 to 11 the members of the council. The purpose of this is three fold. One is to remove the representation of the Chairman of the JCCT to meet Speaker Miller's concerns. It also removes members from the court system and the regents. That narrows the scope of this to the Administrative branch of Kansas government. The revisors also reduced from 4 to 3 the representatives from the private sector. The purpose was to keep an odd number on the committee.

Second, on page 2 the scope of the bill is narrowed to "administrative" policies which is consistent with the direction of the amendments and this addresses the concerns of some of us on the JCCT.

Finally, reference to the Lottery, the board of regents and the information network of Kansas, Inc. are excluded from the scope of this committee again to narrow the focus on the administrative branch of government.

This bill has been worked and reworked. I believe it is good shape and can be to moved forward and successfully become law. I urge this committee to move this bill favorably with the proposed amendments included. Thank you for your time.

Programs for processing the data of any division, department or agency of the state shall be prepared by such division, department or agency of the state in accordance with standards prescribed by rules and regulations adopted by the secretary of administration as provided in K.S.A. 75-4703 and amendments thereto. Notwithstanding the other provisions of this subsection, the division of information systems and communications shall prepare data or programs, or provide technical consultation, when a division, department or agency of the state requests such service of the division of information systems and communications and the director of information systems and communications, subject to the approval of the secretary of administration agrees thereto.

Mr. Chairman, Members of the Committee:

Thank you for the opportunity to appear on Senate Bill 655.

As part of the Reinventing Kansas Government initiative an in depth study was performed on the management of the state's information systems. The project team that examined information systems in state agencies recognized a need to increase quality and lower cost of services provided to Kansas citizens and believed informed application of information technology aligned with defined business strategies would improve the quality of services provided to the people of Kansas into the next century.

The team's vision for establishing that kind of environment is:

1. State policy makers establish and coordinate information technology direction.
2. Information technology professionals are business partners in accomplishing the state's goals and share responsibility for the success of state operations.
3. Processes are in place to define, implement and enforce architecture standards, tools and methodologies.
4. Invest in the state's human resources allowing professional development opportunities, and promoting productivity and innovation.
5. Ensure an infrastructure exists to promote efficient service delivery and data sharing within and among state organizations.
6. That budgeting, accounting and procurement procedures facilitate efficient management and acquisition of information technology resources.

This bill establishes a structure to implement this vision and is a recommendation of the team which the Administration strongly supports.

New Sec. 1 Establishes the Kansas Information Resources Council as a policy making body. Its members are comprised of representatives of the executive, legislative and judicial branches, the Board of Regents, and the private sector.

The Council is charged with the following responsibilities found in New Sec. 2:

- (1) Approve the policies for the management of the state's information resources, including the strategic information management plan;
- (2) provide direction and coordination for the application of the state's information resources;
- (3) approve major information technology and telecommunications projects and provide authorization to proceed with the program plan at specific points of completion;
- (4) designate the ownership of information resource processes and the lead agency implementation of new technologies;
- (5) monitor the return on investment for information resources used within the state; and
- (6) perform such other functions and duties as necessary to carry out the provisions of this act.

The establishment of the Council will facilitate the coordination of information technology standards, tools and methodologies, and is the most positive way to bring about data coordination and sharing.

The bill also establishes the position of a chief information architect who is to be appointed by the Council. The position is designed to provide leadership, guidance and coordination of information technology issues for the KIRC.

The responsibilities of the chief information architect are found in New Sec. 4 and are as follows:

- (a) Initiate and publish the strategic information management plan for the state;
- (b) develop and maintain an information infrastructure and standards for data management.

- (c) serve as secretary to the Kansas information resources council;
- (d) propose information resource policies and procedures for approval by the Kansas information resources council;
- (e) coordinate implementation of new computer and telecommunication technologies;
- (f) coordinate the integration of the state strategic plan and business processes and information technology where appropriate;
- (g) audit compliance with infrastructure standards and review findings with the organization for appropriate action; and
- (h) serve as counsel to agency executives for information technology investment management.

The Department of Administration's Division of Information Systems and Communication's (DISC) role is redefined to allow that organization to focus on providing central computer and telecommunication services; thus the State's central information resource has a clearly defined central service role allowing for more effective service delivery. DISC currently has a conflicting role between services and control.

In the remaining sections of the bill, various statutes are amended to give the Kansas Information Resource Council approval authority over planning and acquisition of equipment, programs, systems and maintenance. Currently, this authority rests with the Secretary of Administration and is administered by DISC.

In an age where information technology is increasingly important, it is vital that we in Kansas carefully structure our management policy to provide and promote the most effective use of dollar and human resources possible. I believe Senate Bill 655 enables us to do that.

The Senate Amendment in New Sec. 9 calls for abolishment of the Council on July 1, 1997.

I propose an amendment to review the effectiveness of the Council utilizing a K-GOAL audit. It will be very difficult to attract a highly qualified individual for the position of the Chief Information Architect with this provision which puts into question continued employment beyond July 1, 1997.

I urge your support of the bill.

INFORMATION SYSTEM MANAGEMENT

The Information System Management team studied information systems and telecommunications in the State of Kansas. The team found the systems and services to be in working order and accomplishing the daily activities needed by the State, although some processes and systems could benefit from several changes. The team proposes and the Steering Committee endorses several initiatives to enhance the effectiveness of the information resource assets of the State. The initiatives in this report provide a path to the vision the team has outlined. The vision was created reviewing fundamental issues and problems revealed in the surveys and interviews accomplished during this study.

FINDINGS

Kansas state government is a complex combination of organizations and functions providing a wide variety of services to citizens and other customers. Information technology currently plays an important supportive role in the conduct of the state's business. A need exists to increase the quality and lower the cost of services provided to Kansas citizens through customer-focused process improvement and informed application of information technology. To that end, state organizations should embark on a journey of continuous process improvement, define business strategies, and align their use of information technology with those strategies to improve the quality of services provided to the people of Kansas into the next century.

VISION

Our vision is to establish an environment where:

- State policy makers establish and coordinate information technology direction.
- Information technology professionals are business partners in the accomplishment of the State's strategic goals and share responsibility for the success of state operations.
- Processes are in place to define, implement, and enforce architecture standards, tools and methodologies.
- Investments in the state's human resources allow professional development opportunities that promote productivity and innovation. Key information

technology professionals are properly compensated and are not penalized for risk taking.

- An infrastructure exists to promote efficient service delivery and data sharing within and among state organizations.
- Budget, accounting, and procurement procedures facilitate efficient management and acquisition of information technology resources.

QUICK HITS

- Discontinue the required approval by the Division of Information Systems and Communications (DISC) for procurement of information technology if the total cost is not more than \$50,000, the item is on state contract, the item is a continuation of established policy; and the organization has in place an internal procedure detailing its Information Technology requisition review process.
- Reduce the number of state contracts regarding maintenance service for information technology hardware.
- Review existing object codes in the accounting system (STARS) to identify sub-object codes that can be merged or eliminated and establish new subobject codes to better track state expenditures for information technology.

MAJOR INITIATIVES

- Charter and establish the Kansas Information Resource Council (KIRC) to set statewide Information Resource Management policy, direction, and priorities; review and approve proposals from the state Chief Information Architect; and assure the linkage of information technology planning and statewide business strategies to achieve the state's strategic goals and Information Resource vision.
- Charter, establish, and fill the position of Chief Information Architect who will create and staff a

support organization to define, propose, and implement the tasks and projects necessary to achieve the Information Resource vision of the state.

- Redefine and rename the Division of Information Systems and Communications (DISC) to allow the organization to focus on provision of central computer and telecommunication services.
- Establish the inter-agency Information Technology Advisory Board (ITAB) to assure consistent implementation of Information Technology policy as directed by KIRC. This group would advise the Chief Information Architect on technical issues facing the state and its organizations and instigate sharing of state resources and data.

SUMMARY

The proposed initiatives establish a framework for effective information resource management in Kansas. Information resource policy, direction, and support for statewide strategic business goals will be the charge of the KIRC. The Office of the Chief Information Architect is designed to provide leadership, guidance, and coordination of information technology issues for the KIRC and the ITAB. A redefined and focused DISC will provide central computer services and telecommunications management. Creation of the ITAB establishes a structure to bring together information professionals from across state government to recommend and implement standards, respond to technology developments, and provide advice and counsel to the Chief Information Architect and KIRC.

These entities, working in concert, will increase communication and consensus on information resource issues, establish meaningful standards to guide technology deployment, and promote shared ownership in the decision making process among all sectors of state government. The process established by these initiatives will advance the informed management of the state's investments in this increasingly critical arena while establishing a foundation to support the goals and objectives of Kansas Quality Management.

This bill is based on a State, private sector team report produced in late 1993. Figure 1 illustrates the process used to determine initiatives and plans.



Given the fundamental issues, knowledge of activities in other states and the private sector, the team developed a Shared Operating Vision for the effective and efficient application of information technology within the State.

Shared Operating VISION

Today, Kansas state government is a complex combination of organizations and functions providing a wide variety of services to citizens and other customers. Information technology currently plays an important supportive role in the conduct of the state's business.

There is a recognized need to increase quality and lower cost of services provided to Kansas citizens through customer focused process improvement and informed application of information technology. To that end, state organizations must embark on a journey of continuous process improvement, define business strategies, and align their use of information technology with those strategies to improve the quality of services provided to the people of Kansas into the next century.

Our vision is to establish an environment where:

- State policy makers establish and coordinate information technology direction
- Information technology professionals are business partners in the accomplishment of the State's strategic goals and share responsibility for the success of state operations
- Processes are in place to define, implement, and enforce architecture standards, tools, and methodologies
- An infrastructure exists to promote efficient service delivery and data sharing within and among state organizations
- Investments in the state's human resources allow professional development opportunities that promote productivity and innovation. Key information technology professionals are properly compensated and are not penalized for risk taking.
- Budget, accounting, and procurement procedures facilitate efficient management and acquisition of information technology resources

A management structure must be established to enable strategies and plans to move toward attainment of the vision. Figure 3 shows the relationships and fundamental responsibilities of such a structure.



**TESTIMONY BEFORE THE
HOUSE COMMITTEE OF GOVERNMENTAL ORGANIZATION AND ELECTIONS
REGARDING SENATE BILL 0655
March 21, 1994**

Mr. Chair, thank you for the opportunity to present my opinion on Senate Bill 655. I am Ben Nelson, Bureau Chief of the Bureau of Computer Services, Department of Transportation, a position I have held for eight years.

The information technology industry is undergoing a fundamental change. Allow me to quote from Paradigm Shift, a book written by Don Tapscott and Art Caston in 1993¹. This book was highly endorsed by senior managers at Xerox, Travelers Insurance, IBM, NCR, American Airlines, and others.

"A fundamental change is taking place in the nature and application of technology in business. This change has profound and far reaching implications for your organization and for you.. Driven by the demands of the new, competitive business environment on the one

hand and profound changes in the nature of computers on the other...the information age is evolving into a second era. Organizations that do not make this transition will fail. They will become irrelevant or cease to exist."

This change is happening here in Kansas. We are quickly moving to a new paradigm that reinvents fundamental areas such as hardware, software, organizational processing of information, and even the business processes themselves. A survey was conducted four months ago of 1700 Chief Executive Officers and Senior Managers within the greater Kansas City Area, Topeka, and Wichita. The survey shows this year 86% will carry out a major strategy to increase Information Services investment, 76% will carry out a strategy to develop Distributed Systems, and 62% will carry out Business Process Reengineering.² It is my opinion that State Government will mirror this trend in the private sector.

Computer hardware is continuing to change at a staggering rate. If you bought an automobile in the last two years you have more computing power than Neil Armstrong had in his Lunar Landing module. The industry now measures hardware speed in terms of MIPS (millions of instructions processed each second)

per ounce of hardware weight.³ A PC purchased in a department store today can process more instructions per second than all of the state computers when the Division of Information Services and Communications was organized. Hardware is no longer purchased from a single vendor but from multiple vendors who offer the "best of breed." Responsibility for integrating hardware components has shifted from the vendors to the users. Users without well thought out and robust standards and architectures cannot succeed in today's environment.

Software is rapidly changing from artisanship production to Total Quality Management manufacturing. To achieve productivity from this change, the State will need to introduce engineering-type discipline in its methods, tools, and procedures. Again, effective use of resources is only possible through well-developed, continuously improving processes guided by an information technology management structure that is, itself, continuously improving.

Successful information Technology support units will realign, based upon a solid business foundation rather than purely technological or other non-business considerations. This realignment is best helped by a management structure that views information technology as one of many elements forming a strategic view of state needs. This management structure will be successful if, and only if, it is

driven by a team of top-level government leaders.

Business processes need to be reengineered to achieve the promise of our Kansas Quality Management program and its demand for continuous improvements. This drives us to shift from the idea of producing ONE grand IT Strategic Plan to an era of achieving Continuous Learning Actions. Agency IT strategies become integrated into agency business strategies and the agency business strategies become the basis for a continuously improving statewide process. By accomplishing this we can move from inward agency information technology thinking to include the external business relationships of the state. Differences between agencies are diminished and supplier/customer support teams are organized along functional lines to solve statewide issues.

Senate Bill 655 will allow Kansas to meet these challenges by providing a structure that can best manage the States approximately \$146 million of expenditures for Information resources per year.⁴

About half of the states⁵ have already set up, or are in the process of setting up, a structure similar to that of Senate Bill 655. They, too, recognize the

Mr. Chairman and members of the Committee:

My name is David Buhler and I am here speaking on behalf of
the Information Network of Kansas.

The Information Network of Kansas is neutral on the policy
decision of whether to enact SB 655.

However, the Information Network of Kansas would recommend an
amendment to the bill.

We attended the hearings before the Joint Committee on
Computers and Telecommunications on SB 655, on March 8, 1994, and
understood Secretary of Administration, Susan Seltsam, to testify
it was not her intention to repeal the exemptions under the
current law for the Regents universities and the Kansas Lottery.

These exemptions appear in Sections 5 and 6 of the bill. It
is our understanding that the JCCT Committee supported the
restoration of those exemptions.

It has always been the understanding of the Information Network of Kansas that INK was likewise exempt from these provisions of the law. I have attached a copy of the pertinent statutes that created INK and established its authority.

You will note that under these statutes, INK is a free-standing public instrumentality created by the Legislature, which is governed by a board of directors, one of whom is the director of DISC who serves as a non-voting member.

These statutes expressly include, among other duties, that INK is to cooperate with DISC, but clearly does not place INK under the supervision or jurisdiction of DISC.

In fact, under the same statutes DISC is directed to provide INK with such staff and other assistance as may be requested from time to time.

The Information Network of Kansas would therefore request that SB 655 be amended to expressly exempt the Information Network of Kansas from the provisions of this bill.

This could be done by inserting in Section 5 on page 4, line 16, and in Section 6, page 4, line 37, the following language:

"This section should not apply to Information Network of Kansas".

In the alternative, if it is the intent of the committee to restore the current exemption for universities and the lottery in these same sections of the bill, then you could simply add to those exemptions the language "or to the Information Network of Kansas".

We would urge the favorable consideration of these amendments, and I would be happy to answer any questions that you might have.

74-9304. Same; duties and responsibilities; state agencies to cooperate and provide services and information; services and information to be provided pursuant to contract; agency may recover actual cost incurred. (a) In order to achieve its purpose as provided in this act, INK shall:

(1) Serve in an advisory capacity to the secretary of administration, division of information services and communications and other state agencies regarding the provision of state data to the citizens and businesses of Kansas;

(2) seek advice from the general public, its subscribers, professional associations, academic groups and institutions and individuals with knowledge of and interest in areas of networking, electronic mail, public information access, gateway services, add-on services and electronic filing of information; and

(3) develop charges for the services provided to subscribers, which include the actual costs of providing such services.

(b) All state agencies shall cooperate with INK in providing such assistance as may be requested for the achievement of its purpose.

Agencies may recover actual costs incurred by providing such assistance. Services and information to be provided by any agency shall be specified pursuant to contract between INK and such agency and shall comply with the provisions of K.S.A. 45-215 et seq. and 21-3914, and amendments thereto.

74-9305. Same; network manager, duties and compensation; contracts for consulting, research and other services; gifts, grants and donations, acceptance; not subject to state purchasing laws. (a) INK shall hire a network manager, which may be either a person or a company or corporation. INK shall draw criteria and specifications in consultation with the division of information services and communications for such a network manager and its duties. INK may negotiate and enter into an employment agreement with the network manager selected which may provide for such duties, responsibilities and compensation as may be provided for in such agreement.

(b) The network manager shall direct and supervise the day-to-day operations and expansion of such gateway and network, including the initial phase of operations necessary to make such gateway operational, and:

(1) May employ, supervise and terminate such other employees of INK as designated by INK;

(2) shall attend meetings of INK;

(3) shall keep a record of all gateway, network and related operations of INK, which records shall be the property of INK, and shall maintain and be a custodian of all financial and operational records, documents and papers filed with INK; and

(4) shall yearly update and revise the business plan of INK, in consultation with and under the direction of INK.

(c) INK is hereby authorized to negotiate and enter into contracts for professional consulting, research and other services.

(d) INK may accept gifts, donations and grants.

(e) INK shall not be subject to state purchasing laws.

(a) The employees of INK shall be considered to be state employees, and INK shall be considered to be a state agency for purposes of the laws and procedures governing the payroll accounting system for state agencies under K.S.A. 75-5501 *et seq.*, and amendments thereto, the deferred compensation plan developed and approved for state employees under K.S.A. 75-5521 through 75-5529, and amendments thereto, the Kansas public employees retirement system, the employment security law, the workers compensation act, including the state workers' compensation self-insurance fund as provided in K.S.A. 44-575 through 44-580, and amendments thereto, the state health care benefits program and remittances pursuant to the federal social security act, federal insurance compensation act and the federal internal revenue code. All employees of INK shall be considered to be state employees and INK shall be considered to be a state agency only for the purposes specified in this subsection.

(b) The provisions of article 32 of chapter 75 of the Kansas Statutes Annotated, any acts amendatory thereof or supplemental thereto, and any rules and regulations adopted thereunder, shall not apply to officers or employees of INK. Subject to policies established by the board of INK, the chairperson of INK or the chairperson's designee shall be authorized to approve all travel and travel expenses of such officers and employees.

(c) Nothing in this act shall be construed as placing any officer or employee of INK in the classified service or unclassified service under the Kansas civil service act.

(a) There is hereby created a body politic and corporate to be known as the Kansas commission on the future of health care, inc. The commission is hereby constituted a public instrumentality and the exercise of the authority and powers conferred by this act shall be deemed and held to be the performance of an essential governmental function.

(b) The purpose of the commission is to develop a long-range health care policy plan, including both short- and long-term strategies, to identify social values of Kansans and to provide a forum for Kansans to participate in the development of health policy. The long-range health care policy plan shall address prevention oriented services, critical health care needs and incorporate the social values of Kansans. In the process of developing the plan, the commission shall directly involve interested citizens by establishing a network of town hall meetings throughout the state where Kansans can participate in open discussions about health policy matters.

(c) In its reports under this act the commission shall propose and recommend changes to laws and rules and regulations as the commission deems appropriate to achieve the health care goals identified by the commission and monitor such recommendations to encourage their implementation.
