Discussion and action on SB 768-Modifies job expansion and investment credit act

Bob Nugent, Revisor of Statutes, explained the provisions of 3 RS 2562, a Substitute for <u>SB 768</u>. He said if the site of a qualified business facility had been within an existing declared enterprise zone at the time of commencement of construction of such qualified business facility, and which the taxpayer had a reasonable basis to believe that the governing body of the city would declare such site as part of an enterprise zone, thereby entitling the taxpayer to a credit thereunder, shall be entitled to the credit in the amount that would have been allowable to such taxpayer at the time the claim was made pursuant to such act.

After Committee discussion <u>Senator Kerr moved and Senator Reynolds seconded to adopt Substitute</u> for SB 768. The motion carried on a voice vote.

Senator Kerr moved and Senator Ranson seconded to report Substitute for SB 768 favorably for passage. The motion carried on a roll call vote.

A motion was made by Senator Harris and seconded by Senator Burke to adopt the minutes of February 28 and March 1, 1994. The motion carried on a roll call vote.

The Chairman adjourned the meeting at 9:00 a.m.
