SB 2645 - Driver's license content

The staff briefed the Committee on this bill stating that it was requested by the Division of Vehicles. This bill would require that all drivers' licenses issued on and after July 1, 1994 to persons under the age of 21 be readily distinguishable from licenses issued to persons age 21 years or older. This change would permit the Division to better identify driver license holders under the age of 21 when they convert to a digitized license system and provide for a more positive identification.

SB 2646 - Relating to the Division of Vehicles

The staffed briefed the Committee on this bill which would mandate that all photographs maintained by the Division in connection with the issuance drivers' licenses be kept confidential. This clarifies that no person, including a commercial employer, is entitled to receive a license photograph.

The Committee briefly discussed these bills and asked questions.

Senator Burke made a motion to pass SB 2645 favorably. A second was made by Senator Jones. Motion carried.

Senator Burke then made a motion to pass SB 2646 favorably. Senator Tiahrt seconded this and the motion carried.

A motion was made by Senator Jones to approve the minutes of the February 24 and February 25 minutes. A second was made by Senator Tiahrt. Motion carried.

The meeting was then adjourned by the Vice-Chairperson.
