Rep. Swenson made a motion to approve the minutes of January 25 and 26. The motion was seconded by Rep Packer. The minutes were approved as written.

The minutes of January 27 and 31, and February 1, 2, and 3 were handed out. We will approve them at the committee meeting on February 22.

Hearing on: HB 2499--Home building and owning corporations, board member appointed by county commissioners

Bob Nugent gave the committee a brief explanation of <u>HB 2499</u>. The bill originated in a Local Government Sub-Committee. It was requested by cities and counties. The original statute appointed a director of a home building corporation. Mr. Nugent called the Secretary of State's office, and as far as they knew, this position had not existed for many years. The bill would have them treated as any other not-for-profit corporations.

Rep. Bob Tomlinson appeared as a proponent of HB 2499 (see Attachment 1). He said the sub-committee was set up to look at mandates or legislation in the Statute Books that may or may not have a purpose. They asked the League of Municipalities and the Kansas Association of Counties to bring to them any piece of legislation that they believed no longer served a purpose. This statute was one that was brought to the sub-committee. The reason that the Secretary of State could not find any of these corporations is they have not been in existence for years. The sub-committee is looking to repeal about 100 sections and this bill repeals one of them. These unnecessary mandates cost the cities and counties time and money and need to be repealed. Rep. Tomlinson answered questions from the committee.

Paul Flowers, Kansas Association of Counties, spoke from the audience. His association concurs with Rep. Tomlinson's testimony on **HB 2499**.

Chairman Lane closed the hearing on HB 2499.

Rep. Geringer made a motion to pass out **HB 2499** favorably, it was seconded by Rep. Beggs. The motion passed and the bill will be placed on the Consent Calendar.

Chairman Lane introduced Jim Ludwig, of Western Resources, who showed two videos; Electric & Magnetic Fields; Fact, Not Fears, (Reddy Communications 4/92), and Utility Workers & EMF - Study Results. Mr. Ludwig also passed out to the committee two booklets; EMF in Your Environment, and Your Guide to Understanding EMF. The videos and booklets are available at Western Resources, copies are also available in Rep. Lane's office.

Tom Bozeman, Director of Transmission & Sub-Station Engineering, Western Resources ended the presentation by answering questions from the committee.

The meeting was adjourned at 9:50 a.m.
