The meeting opened for discussion and action on <u>HB 2301 an act concerning school districts</u>; relating to the instruction on human sexuality and AIDS.

Representative Horst moved and Representative Shore seconded motion to amend **HB 2301** deleting the: Line 16 beginning with Pupils to end of sentence at line 18 on page 2, and page 2 line 8 "with or without condoms" in addition to the written changes outlined. (Attachment 1)

Representative O'Connor requested the separation of the amendments. Chairman Chronister stated the question would be divided. The first section to be page 1, line 20, the addition of "include within such instruction, but shall not be restricted to." Motion carried.

Representative O'Connor suggested dropping "citing the failure rates of condoms" at page 2, line 17.

Representative O'Connor moved and Representative Larkin seconded motion to amend page 2, line 17, Pupils shall be provided with statistics based on the latest medical information in preventing AIDS and other sexually transmitted diseases." Motion carried.

Representative O'Connor moved and Representative Morrison seconded motion to amend (i) line 21, page 2 to read: Advising pupils of the circumstances under which it is unlawful for a person to engage in sexual acts. Deleting the rest of lines 22, 23, 24. Motion fails on a division of 9 to 10.

Representative Reardon moved and Representative Pettey seconded motion to strike at (d) all of lines 33 thru the word "inspection" on 39, Motion fails on a division of 9 to 10.

Representative Swenson moved and Representative Ballou seconded motion to amend "before teaching human sexuality and AIDS prevention education, all materials and curricula shall be made available for inspection and critique by parents and guardians." (Lines 33 to 39) Motion carried.

Representative Tanner moved and Representative Powers seconded an amendment to line 42,(sentence beginning at line 41 "Refusal to take or participate in such course") line 42: "or programs shall be not reason for penalty, suspension, expulsion or other penalization of such pupil." Motion carried.

Representative Powers moved and Representative Ballou seconded motion to pass favorably HB 2301 as amended Motion carried.
