Action on SB 204 --Banking federal Riegle-Neal interstate banking and branching act Representative Samuelson moved to accept the amendment proposed by the Office of the Bank Commissioner which would make Sections 1 through 10 effective September 29, 1995, and the balance of the bill effective upon publication in the Kansas Register. The motion was seconded by Representative Correll. Motion carried.

Representative Correll moved to accept the amendment proposed by the Community Bankers Association regarding notification of the Bank Commissioner of agreements or terminations of bank transactions. The motion was seconded by Representative Dawson. Motion carried.

Representative Samuelson moved that the bill be passed out favorably as amended. Motion was seconded by Representative Gilbert. Motion carried.

<u>Action on SB 25--</u>Defining student banks and providing for exemption from banking codes regulation

Representative Landwehr moved that the bill be reported favorably. Motion was seconded by Representative Wilson. Motion carried.

Action on SB 249--Bank powers, life insurance policies

Representative Humerickhouse moved to report the bill favorably. Motion was seconded by Representative Samuelson. Motion carried.

Action on SB 24--Closed meetings of state banking board

Representative Dawson moved to pass the bill out and place it on the Consent Calendar. Motion was seconded by Representative Crabb. Motion carried.

Action on SB 287-Banks and banking; limitations on loans

Representative Dawson moved to pass the bill out favorably. Motion was seconded by Representative Humerickhouse. Motion carried.
