Buck Hartley, Fire Chief Shawnee Kansas, appeared before the committee with a bill request regarding smoke detector legislation.

Representative Graeber made a motion to have this bill introduced as a committee bill. Representative Grant seconded the motion. The motion carried.

Alan Cobb, City of Wichita, appeared before the committee with a bill request that would amend Kansas Asset Forfeiture Act to include the following "driving or attempting to drive a vehicle while a persons privilege to drive is suspended or revoked provided in K.S.A. 8-1567".

Representative Powell made a motion to have this bill introduced as a committee bill. Representative Graeber seconded the motion. The motion carried.

HB 2177 - Venue for actions against corporations & HB 2111 - Civil procedure, change of venue

Representative Powell made a motion to amend the provisions of **HB 2111** into **HB 2177**. Representative Graeber seconded the motion.

Representative Heinemann made a substitute motion to change Chapter 61 so it was consistent with Chapter 60. Representative Nichols seconded the motion. The motion carried.

Representative Powell renewed his motion to amend the provisions of **HB 2111** into **HB 2177**. Representative Graeber seconded the motion. The motion carried.

Representative Nichols made a motion that would add the following language in line 18 "unless the county of the District Court considering the transfer would provide equal convince to both parties." Representative Edmonds seconded the motion.

Representative Pauls made a substitute motion to delete in line 17 the word "well" and add the language "would better serve". Representative Goodwin seconded the motion. The motion carried.

Representative Powell made a motion to report HB 2177 favorably for passage as amended. Representative Yoh seconded the motion. The motion carried.

Chairman O'Neal announced that <u>HB 2030</u> - crime of official misconduct, was assigned to subcommittee because it appeared to need the language cleaned up. Members of the subcommittee are: Graeber, Chairman; Adkins, Grant, Haley, Pauls.

HB 2002 - mitigating circumstances during sentencing

Representative Nichols made a motion to report **HB** 2002 favorably for passage. Representative Powell seconded the motion.

Representative Graeber commented that this amendment would be discriminatory to other criminals who are not convicted of capitol murder cases.
