Chairman King called the meeting to order at 1:40 p.m.

The Chair recognized Dale Dennis, Assistant Commissioner of the Department of Education, to give an update on the transition of the school bus safety program from the Department of Transportation to the Department of Education. Mr. Dennis stated the transfer was recommended by the Secretary of Transportation to bring the State of Kansas in line with most other state departments of education which currently oversee school bus transportation. School Bus Safety Education Unit

My purpose in appearing before you today is to review the transfer of the School Bus Safety Education Unit from the Kansas Department of Transportation to the Kansas State Board of Education which became effective July 1, 1994.

The transfer was recommended by the Secretary of the Kansas Department of Transportation to bring the State of Kansas in line with most other state departments of education which currently oversee school bus transportation. We have received input from school district personnel that information concerning school transportation is now reaching them sooner. One of the methods of disseminating information to districts is a weekly newsletter which includes a section dealing with transportation issues.

The school bus safety team consisting of a supervisor and two trainers attended the Kansas State Fair last September. Their purpose was to promote safe riding practices with the aid of a miniature robotic school bus named Buster. Over 67,000 people observed Buster while at the fair and another 10,860 school children participated in the Buster Bus program in their schools. As required by state regulation, the school bus safety team also provides:

- 1. Monthly bus driver safety meetings including
 - a. smoking the school bus with a theatrical fogger
 - b. evacuation drills to drivers:
- Evacuation drill demonstrations to students;
- First aid and CPR classes;
- 4. Driver improvement classes; and
- Annual recertification defensive driving classes.
