MINUTES OF THE HOUSE COMMITTEE ON TRANSPORTATION.

The meeting was called to order by Chairperson Kenneth King at 1:30 p.m. on February 22, 1995 in Room 519-S of the Capitol.

Chairman King called the meeting to order at 1:35 p.m.

The Chair recognized the Amanda Arnold School from Manhattan and welcomed them to the committee.

Chairman King opened hearings on <u>HB 2538</u>, designating a portion of K-96 highway as the State <u>Fair Freeway</u> and called on Bruce Kinzie to give an overview of the bill.

The Chair recognized Representative Pauls who spoke in support of the bill. She stated she introduced this legislation, which would designate Highway 96 from Wichita to Hutchinson as the State Fair Freeway, at the request of Bob Gottchalk, Executive Director of the Kansas State Fair. She told the committee in 1913 the State legislature officially designated the fair in Hutchinson as the Kansas State Fair and the designation of the four lane between Wichita and Hutchinson was a fitting tribute for this valuable Kansas asset. (Attachment 1)

There were no other proponents or opponents and the Chair closed hearings on HB 2538.

Chairman King opened HB 2432, concerning all-terrain vehicles; relating to the operation thereof. Representative Shore made a conceptual motion which would substitute the word "maintenance" for "spraying" by all-terrain vehicles owned or contracted for service by the State or county, seconded by Representative Myers.

There were some concerns by the committee that volunteer groups, such as Adopt-A-Highway, who also sign a contract with the state, would be able to use all-terrain vehicles for their cleanup. Representative Myers withdrew his second and Representative Shore withdrew his motion.

Representative Shore made a motion to pass HB 2432 favorably, seconded by Representative Pauls and the motion carried.

The Chair next opened **HB 2446, concerning the division of vehicles records** and Bruce Kinzie gave an overview.

Representative Edmonds made a motion to amend HB 2128, Section 1 through 3, into HB 2446, changing Section 2, lines 35-36 of HB 2128, to indicate a white color rather than the blue/gray color specified, seconded by Representative Shore.

Upon questioning as to whether these two bills were compatible the Chair ruled they were germane and called for a vote. The motion failed.

This bill was filed at the request of the Kansas State Fair, to designate Highway 96 from Wichita to Hutchinson as the State Fair Freeway. The highway signs or markers would be paid for by gifts or donations.

The Fair began in Hutchinson in 1875 as the Reno County Fair, then in 1887 became the Hutchinson Fair (which was a state-wide fair) and then became known as the State Fair in 1901. In 1913 the State legislature officially designated the fair in Hutchinson as the Kansas State Fair.

The fair itself has existed for one hundred and twenty years. the Kansas State Fair has existed officially as the State Fair for eighty-two
