The Chairperson called on staff to explain information handed committee members concerning a report ranking water quality in each state (<u>Attachment 1</u>). Staff stated the information was received from KDHE and came from a much larger report put out by the Council of State Governments. Staff stated there is controvery over the report, there is also apparent controversy as to how the report should be read in terms of comparison of the states, in terms of how many miles of stream they determined should be accessible to human contact and how many points or locations within the state are tested for particular kinds of contaminants.

Mr. Ron Hammerschmidt, Acting Director, Health, KDHE, told the committee his organization was obtaining copies of this bi-annual report that the states must prepare on water quality. He further stated there is no uniform criteria states have to use for their assessments. Mr. Hammerschmidt told members his department were getting reports from the surrounding states and will prepare a briefing document for the committee.

A member stated we are taking water from other states and questioned the quality at the time of receipt in Kansas.

HB 2032: Concerning the central interstate low-level radioactive waste commission

Al Ledoux, Legislative Liaison with the Governor's office, speaking as a proponent for <u>HB 2032</u>, told the committee this particular legislation was designed to allow for a smooth transition between administrations as far as the central interestate low-level radioactive waste commission were concerned. Mr. Ledoux advised the committee a new secretary for health and environment would soon be in place but it was felt someone who was current with this situation should be available for response in the event action was needed.

Senator Lawrence made a motion to report HB 2032 favorable for passage. Senator Hardenburger seconded the motion and the motion carried.

The meeting adjourned at 8:18 a.m.

The next meeting is scheduled for February 7, 1995.
