MINUTES OF THE SENATE COMMITTEE ON PUBLIC HEALTH AND WELFARE.

The meeting was called to order by Chair Sandy Praeger at 1:00 p.m. on April 27, 1995 in Room 527-S of the Capitol.

Confirmation Hearing on Rochelle R. Chronister, Secretary, Social and Rehabilitation Services

Senator Tim Emert introduced State Representative Rochelle R. Chronister, governor's appointee as Secretary of Social and Rehabilitation Services.

Representative Chronister addressed the Committee and commented that a new organizational chart for SRS would be in place by the start of the 1996 Legislative session. She noted in her written testimony that the agency has grown to the point where it is no longer manageable, and a "spinoff" of certain entities of SRS should be made for a more efficient total management scheme of state government. Other areas of interest related to the privatizing of all child support enforcement services, as well as to examine a single point of entry for all health and welfare services, determine what state mental health and mental retardation hospitals should be closed or converted to other uses, continue the conversion to community support services in the area of mental health and mental retardation, facilitate the adoption of children who have had their parental rights severed, support community service for welfare recipients, and cooperate with the Department of Aging so that the aging population can remain in their own homes as long as possible. Representative Chronister did not feel that SRS has operated the juvenile offender system well, and that part of the agency should become part of the Corrections system or be a separate youth authority. (Attachment 1)

During Committee discussion some areas of interest and comments related to the need for SRS accountability, a credit card program for food stamp recipients and electronic benefits transfer, closure of mental retardation and mental health hospitals with available community services in place, and a teenage pregnancy prevention program. Representative Chronister also expressed her support for the Medicaid managed care process.

Senator Ramirez made a motion the Committee recommend Rochelle R. Chronister be confirmed as Secretary of Social and Rehabilitation Services, seconded by Senator Walker. The motion carried.

The meeting was adjourned at 1:30 p.m.

I think we should examine a single point of entry for all health and welfare services.

We must determine what state mental health and mental retardation hospitals should be closed or converted to other uses to put an end to the turmoil in the lives of clients and staff.

Confirmation Hearing: Rochelle Chronister April 27, 1995

I support continuing the conversion to community support services in the areas of mental health and mental retardation.

I believe we must do everything that we can to facilitate the adoption of children who have had their parental rights severed as quickly as possible.

Our aging population want to remain in their own homes as long as possible, and I propose working with the Department of Aging to accomplish that goal.

I firmly believe that everyone who is able to work should do so, and that if they are on welfare, we should find some type of community service that they can do to earn their checks.

I do not feel that SRS has operated the juvenile offender system well. That part of the agency should become part of the corrections system or be a separate youth authority. I do not support including "children in need of care" in that authority even though I recognize that the two groups overlap.

The rehabilitation services portion of SRS should be carefully examined to see if all parties would be better served under Human Resources or the Department of Health.

This is not a comprehensive listing of what I believe we should accomplish, but it is a starting point for the direction I believe we should head.
