HB 2051 - RELATING TO TELEPHONE SERVICE BY RAILWAY, EXPRESS AND TELEGRAPH COMPANIES

This legislation concerning the Southwestern Bell Corporation would repeal a statute that is obsolete. (Attachment 1)

HB 2053 - CONCERNING STATE CORPORATION COMMISSION

This bill would change a section of law which relates to stays or suspensions of the State Corporation Commission orders, to secure the prompt payment of the party petitioning for the stay, all damages caused by the delay in the endorsement of the order or decision of the Commission. (Attachment 2)

A written statement from Rob Hodges, President of the Kansas Telecommunications Association, was submitted on these two bills. They endorse their passage. (Attachment 3)

A motion was made by Senator Harrington to pass these bills favorably and place them on the consent calendar. This was seconded by Senator Emmert. Motion carried.

Senator Sallee asked for introduction of a bill for federal exemptions for motor fuel when sold on Indian Reservations to non reservation customers.
