A motion was made by Representative Neufeld, seconded by Representative Helgerson, to introduce a bill concerning Hospital District elections. The motion carried.

Chair Jennison, Committee members and fellow conferees:

Thank you for the opportunity to appear before this committee in support of HB 2952.

There has been a Sea-change in Kansas. The process appropriations process in Kansas is now, in fact, different than it has been in years past. For good or bad, the legislature was presented with a budget that was smaller than last year's budget. And our half of the legislature has, for the first time in memory, acted on that budget in a single bill. The process, whether we prefer it or not, is now different. We are operating under new and different rules. And for those different rules, we need different tools. HB 2952 is such a tool for our use.

When the House adopted the Governor's budget as a part of one bill, the line for next year's appropriations formed outside the Governor's office and the budget director's office later that same day. We told everyone in the state, as we should, that the budget process starts with the Governor's budget and that it has now become critical for anyone with an interest in Kansas' appropriations to make certain that their interest and their numbers are in the Governor's budget. That is as it should be. But without a backstop, without some lever or hammer, the Governor's office will now be the seat of all of the pressure that has always been exerted on the legislature. While I am sure that they can stand the pressure, it will be easier for them to do their job if they can point to HB 2952 and say to the supplicants: Negotiate a reasonable budget with the Budget Director's office and get into the Governor's budget with a reasonable request or you will be out on the floor looking for votes on your own. HB 2952 will strengthen the budget process by giving the Governor's office and the legislature a new choice in the process. Mary Chapin Carpenter sings: "Cut the deck right in half, I'll play from either side." That is what HB 2952 does in the appropriation process. It is fair for either side. Thank you for your time. I hope you can your support HB 2952.
