In the absence of Chairman Jennison, Vice Chairman Carmody chaired the meeting. Chairman Carmody opened the meeting by opening hearings on HB 3081, a sports agent regulation bill. Chairman Carmody recognized Representative Hochhauser to introduce the first conferee on the bill, KSU head football coach, Bill Snyder.

Chairman Carmody then recognized Revisor Wilson to give the committee a briefing on all points of the bill and answer questions.

Chairman Carmody recognized Merle Hill to testify on behalf of Kansas Community Colleges in favor of HB 3081 (Attachment 1). Janet Chubb from the Secretary of State's Office explained the administrative responsibilities of the Secretary of State's Office and stated that the Secretary of State's Office could handle the duties with the proper funding (Attachment 2).

Chairman Carmody closed hearing on HB 3081 and proceeded with further discussion on HB 3044 witch was discussed earlier in the week. Chairman Carmody recognized Representative Neufeld to report further on the bill and answer questions.

A motion was made by Representative Neufeld, seconded by Representative Minor, to amend the subcommittee report to add the Legislative Oversight Committee to the bill. The motion carried.

Chairman Carmody recessed the meeting at 2:05 and stated that the committee would reconvene upon adjournment of the full house today.

Chairman Carmody called the meeting to order at 4:55 p.m.

Discussion on HB 3044 resumed.

motion was made by Representative Helgerson, seconded by Representative Wilk, to amend the subcommittee report to state that there will be an evaluation of children's programs run by SRS, and post audit will give a proposal of the type of evaluation that will be conducted. The motion carried.

A motion was made by Representative Helgerson, seconded by Representative Wilk, to amend the subcommittee report to add language granting the administration of KDHE to establish contracts with nonprofit organizations to provide services on a broad geographical basis.

For clarification, Representative Helgerson pointed out that CASA and the Citizen's Review Board will be kept with KDHE and those funds would not be contracted out. A motion was made by Representative Neufeld, seconded by Representative Goossen, to adopt the subcommittee report, as amended. The motion carried. Representative Hochhauser voted no.

A motion was made by Representative Helgerson, seconded by Representative Neufled, to amend HB 3044 by including the subcommittee report (the amended substitute bill) and recommend it favorably for passage. The motion carried. Representative Hochhauser and Representative Lowther voted no.

The meeting adjourned at 5:45 p.m.

The 19 community college athletic directors support House Bill No. 3081 and are pleased to see that such action is being recommended to protect the interests and rights of student athletes. One of the athletic directors informed me that what we know about athlete agents and their contacts with young colleges athletes" is just the tip of the iceberg."

This individual, who played in the National Football League for eight years, said he got to know athlete agents quite well during his professional sports career. He suggested that is certainly time for the state to restrict the activities of athlete agents and to protect young college athletes from the "vultures." He did not choose that word lightly.

The athletic directors of the Kansas community colleges strongly support HB 3081 and would request that you recommend it favorably for passage.

# HOUSE APPROPRIATIONS COMMITTEE March 21, 1996 Hearing on HB 3081

Chair Jennison and members of the committee:

Secretary Thornburgh appreciates the opportunity to comment on HB 3081. This bill provides for the registration and regulation of athlete agents by the secretary of state's office.

Our testimony is based upon preliminary interviews and a cursory examination of the industry and the proposed legislation. The public policy promoted by HB 3081 seeks to protect young athletes from unconscionable contracts and fraudulent practices.

Passage of this bill would assign new duties to the secretary of state's office. HB 3081 requires the secretary to "actively enforce" the act by conducting investigations, approving contracts, exercising subpoena power, issuing and revoking registrations and assessing fines up to \$25,000, among other duties, all pursuant to the Kansas administrative procedure act. These regulatory responsibilities have never been assigned to our office. However, the filing duties identified by HB 3081 are similar to other statutory filings performed by the secretary of state's office.

If the legislature adopts this legislation and determines that the secretary of state is the appropriate enforcement agency, we are capable of executing the regulatory scheme contemplated by HB 3081. All we ask is that, if we are assigned this duty, we be given the necessary enforcement tools and funding to establish the standard of "active enforcement" set out by the act.
