Chairperson Allen brought the committee's attention to **SB458** - reorganizing KEIOF, and **HB3068** regarding compensation of officers and employees of KTEC. She informed the committee that the listing of reports to be consolidated under **SB460**, which was requested by Rep. Lane, was distributed to the committee. Chairperson Allen asked Lynne Holt to brief the committee on §B458 and SB460 (Attachment 1). Chairperson Allen suggested the committee take the language in SB460 and put it into SB458.

Rep. Empson made a motion to amend the language in SB460 by adding the date the annual report is to be given to the Legislature and the Governor, and to put this language into SB458. It was seconded by Rep. Kirk. The motion carried.

Rep. Empson made a motion to pass SB458 as amended. Rep. Beggs seconded the motion. The motion carried.

Chairperson Allen brought the committee's attention to **HB3068** - regarding compensation of officers and employees of KTEC. She told the committee the bill was introduced by the Chairman of the House Tax Committee. Chairperson Allen also had an amendment passed out for the committee to consider. She asked Bob Nugent to explain the amendment (Attachment 2).

Rep. Glasscock moved to accept the offered amendment language and replace the previous committee amendment. It was seconded by Rep. Emspon. The motion carried.

Rep. Glasscock made a motion to insert HB2685, KTEC's venture capital tax credit bill, as amended by House committee, into HB3068. Rep. Wempe seconded the motion. The motion carried.

Rep. Glasscock made a motion to pass HB3068, as amended, out of committee favorably. Rep. Beggs seconded the motion. The motion carried.

Chairperson Allen brought the committee's attention to the minutes of March 4, 5,7, and 11, for approval. Rep. Pottorff made a motion and Rep. Empson seconded to approve the minutes. The motion carried.

Chairperson Allen announced the closing of the House Economic Development Committee meetings for the 1996 session.

#### Strategic Planning Report

(K.S.A. 74-5097)

Report made to the Joint Economic Development Committee by the Strategic Planning Program annually on or before September 1. The report on the status of program activities may include but is not limited to, "specifics of community strengths and weaknesses and planning issues and strategies" developed as part of the program.

#### SKILL Program Annual Report (K.S.A. 74-50,111)

Report made to the Joint Committee on Economic Development annually on or before November 1 by the SKILL Program. The report shall include information on the number and characteristics of new jobs created in Kansas under the SKILL Program, including any new jobs reported under the program "which do not continue to exist and the circumstances and effect of any such discontinuances"

### Kansas Economic Opportunity Initiative Fund (K.S.A. 74-50,152)

Report made to the Joint Committee on Economic Development annually on or before September 1 by KDOC&H. The report shall include a "detailed description of how funds were spent, what if any, economic benefits were realized from the expenditures and whether the intended outcomes ... have been realized."

#### Commission on Travel & Tourism (K.S.A. 74-9002)

Report made to the Governor and Legislature Development annually on or before December 31 by the Commission on Travel & Tourism. The report shall include findings and recommendations of the commission regarding the promotion of travel and tourism in Kansas and other related matters.

# Kansas Industrial Training / Industrial Retraining Programs (K.S.A 74-5066)

Report made to the Joint Committee on Economic Development annually by the KIT/KIR programs. No date is provided in statute for this report. The report shall include information on the "performance and cost effectiveness" of the programs.

### Kansas Venture Capital Companies (K.S.A. 74-8310)

Annual report made to the Governor, Legislature, and Kansas, Inc. by the Kansas Venture Capital Program. There is no date assigned in statute for this report. The report shall include information on the number of certified venture capital companies, total tax credit generated, total investments made in Kansas venture capital companies, estimated number of jobs created or preserved under the program, and an estimate of the multiplier effect on the Kansas economy.

#### Seed Capitol Pools (K.S.A. 74-8405)

Annual report made to the Governor, Legislature, and Kansas, Inc. by the Kansas Seed Capital Program. There is no date assigned in statute for this report. The report shall include information on the number of local seed capital pools, total tax credit generated, total investments made in Kansas venture capital companies, estimated number of jobs created or preserved under the program, and an estimate of the multiplier effect on the Kansas economy.

#### Enterprise Zones (K.S.A. 74-50,118)

Report made annually on or before April 1 to the Governor and Legislature by the Enterprise Zone Program. The report shall include information provided by the designated non-metropolitan areas. The report will include information on local incentives for economic development, usage of such incentives committed by local governing bodies, and any other information deemed relevant by the secretary.

### Trade Show Promotion Act (K.S.A. 74-50,146)

Annual report made to the economic development committees of the House and Senate during the legislative session by the Kansas Trade Show Assistance Program. The report shall include information on the types of businesses receiving assistance to participate in trade shows and the results obtained from such participation.

## Export Finance Program (K.S.A. 74-5073)

Annual report submitted by the Export Loan Guarantee Review Committee on or before February 1 to the Governor and the Joint Economic Development Committee. The report is to include a summary of all "activities" of the program.

Be it enacted by the Legislature of the State of Kansas

Section 1. K S A. 1995 Supp. 74-8105 is hereby amended to read as follows: 74-8105 (a) The president shall be the chief executive officer of the corporation and shall serve at the pleasure of the board. The president's salary shall be set by the board of directors. The president shall be in the unclassified service under the Kansas civil service act. The board of directors may negotiate and enter into an employment agreement with the individual selected as president of the corporation which may provide for such compensation and such provisions for allowances, benefits and expenses as may be included in such agreement. The board of directors is authorized to make all payments and payroll deductions as may be required under such agreement. The president shall direct and supervise administrative affairs and the general management of the corporation.

(b) The president:

- (1) May employ and terminate such other officers and employees as designated by the board of directors. Any officer or employee of the corporation who receives compensation allocated from state funds shall receive no other compensation. Such officers and employees shall be in the unclassified service under the Kansas civil service act;
  - (2) shall attend board meetings;
- (3) shall appoint a secretary to keep a record of all proceedings and maintain and be custodian of all financial and operational records, documents and papers filed with the corporation and of the minute book of the corporation; and
- (4) before accepting any applications as provided for under this act, shall prepare a business plan which shall include the corporate analysis of funding levels of programs in other states that are shown in the report required in subsection (b) of K.S.A. 74-8111 and amendments thereto and the threshold funding levels specified in subsection (c) of K.S.A. 74-8111 and amendments thereto. Upon approval of the business plan by the corporation board, the plan shall be presented to the standing com-

including, but not limited to, salaries, bonuses, fees or incentives for performance of any duties on behalf of any entity which is a subsidiary of or is other wise related to the corporation or is a business in which the corporation or any entity related to the corporation has invested state funds. The president's employment contract, including any renewal of an existing contract, shall be made available to the senate commerce committee and the house economic development committee, or if the legislature is not in session, the joint committee on economic development, prior to execution of the contract.
