#### HB 2597: contested elections

Chair Carol Dawson opened the hearing on <u>HB 2597</u> and asked the Legislative Research Department to brief the Committee regarding the bill. Mr. Hodgins explained that the bill defines and sets guidelines to have a three judge panel review contested elections.

The Chair recognized Paul Shelby as a proponent of the bill. He testified that this bill is an improvement to the current method and would make it easier to find judges to serve. See <u>Attachment 1</u>.

## HB 2598: contest elections; enables contestant to use campaign funds to pay costs incurred by the contested election.

The Chair recognized Carol Williams who advised the Committee that an opinion from her office was given at the time of the last contested election and the opinion was that campaign funds could be used to help pay for costs incurred by the contested election including attorney fees. #### 1996 House Bill No. 2597 House Governmental Organization and Elections Committee Janury 17, 1996

Testimony of Paul Shelby Assistant Judicial Administrator Office of Judicial Administration

Madam Chair and committee members:

We appreicate the opportunity to appear before the committee and support House Bill No. 2597 which changes the procedure for hearing contested legislative elections among state senators and representatives.

The bill eliminates the system in which a single judge from the district in which the election is being contested was selected by the contestants, replacing it with a procedure in which the Chief Justice of the Kansas Supreme Court selects a panel of three district judges from outside the district in which the election is being contested to hear evidence and decide the election.

We think this bill is a vast improvement over prior procedures. It takes the parties out of the judicial selection process and assigns judges outside the district which should make it easier to find judges willing to serve. The time frames are tight but should be workable.

We urge the committee to pass the bill favorably.
