MINUTES OF THE HOUSE COMMITTEE ON TRANSPORTATION.

The meeting was called to order by Chairperson Kenneth King at 1:30 p.m. on February 7, 1996 in Room 526-S of the Capitol.

HB 2690 - lemon law, leased vehicles

Staff reviewed the bill and pointed out the technical amendment suggested in Section 1, (1) which would add "or lessee" after purchaser.

Representative Correll made a motion to adopt the amendment, seconded by Representative Donovan and the motion carried.

Representative Dillon made a motion to pass HB 2690, as amended, seconded by Representative Shore and the motion carried.

HB 2667 - relating to all-terrain vehicles

Staff reviewed the bill and went over the changes by section. Staff stated there were four provisions in this bill: 1) permit regulation 2) titling 3) dealer licensing law and 4) traffic regulations.

Betty McBride, Department of Revenue, explained that non-highway titling is one time only and requires showing proof of sales tax payment or pay the sales tax at the time of titling. This requires no tag or permit. Registration requires a tag.

Following discussion Representative McKinney made a motion to strike New Section 3, the annual permitting requirement section, seconded by Representative Humerickhouse and the motion carried.

Representative Humerickhouse made a motion to restore the stricken language in Section 5 (6), however, making an infraction of this section a traffic violation instead of a misdemeanor. This was seconded by Representative McKinney and the motion carried.

Following discussion regarding the dealer licensing act, Section 10, <u>Representative Powell make a motion to strike the requirement which includes all-terrain dealers, seconded by Representative Dawson and the motion carried.</u>

Staff presented a possible amendment which would not require the owner of an all-terrain vehicle to file an application for a nonhighway certificate of title unless the person transfers an interest in such all-terrain vehicle.

Representative Dawson made a motion to accept this amendment, however, to change the date from January 1, 1997 to July 1, 1996, seconded by Representative Shore and the motion carried.
