Confirmation hearing on the appointment of Susan Bittell, Member, Kansas Technology Enterprise Corporation, term expiring January 15, 1998.

Susan Bittell, testified she had seventeen years of marketing experience, working in an advertising agency, teaching at a University, working for a nonprofit organization and a manufacturer. Ms. Bittell stated she served as a consultant for the Small Business Development Center in western Kansas. She is presently national marketing director of Wheelchairs of Kansas. Ms. Bittell stated her present position has enlightened her first hand as to how technology applies to manufacturing and what MAMTEC has to offer. Wheelchairs of Kansas has been assisted by Western Kansas Technology Corporation, the Center for Design, Development and Production, and KTEC's office of Innovation & Research. Ms. Bittell stated she represented the private sector of the KTEC Board and is concerned regarding the Board's accountability in light of Kansas Inc.'s Report and the KTEC response. Ms. Bittell stated her support for the idea of regional business centers and believes such a concept would work well in the western part of the state, and particularly the "one-stop shopping" approach. Confirmation hearing on the appointment of Kurt Saylor, Member, Kansas Technology Enterprise Corporation, term expiring January 15, 1999.

Kurt Saylor, testified he had twenty years experience as a banker in Sabetha and the surrounding area of northeast Kansas. Mr. Saylor stated he is experienced in the financial and lending field; can read a balance sheet and understands high risk loans. He has put together financial packages for companies, at both the local and international level. Mr. Saylor stated he believes his experience in the banking industry and his familiarity with the lending aspect of banking, particularly, is beneficial to the KTEC Board and that he can make a contribution to economic development and creation of jobs.

Confirmation hearing on the appointment of Tracy B. Taylor, Member, Kansas Technology Enterprise Corporation, term expiring January 15, 1998.

Tracy B. Taylor, testified he has had fifteen years experience in the areas of mergers, acquisitions and venture capital, working at the World Headquarters of Ford Motor Company, Butler Manufacturing, and Sprint Corporation. Mr. Taylor stated he reviewed business cases of emerging companies for the purpose of assessing valuations, product viability, soundness of strategy, financing structure and marketability. He stated he has a keen interest in the subject of both venture capital and economic development for the state of Kansas. Mr. Taylor advised he is currently managing partner, Cohen-Esrey Housing Partners. Mr. Taylor stated his business and entrepreneurial experience will be of benefit while serving on the KTEC Board, as it enables him to sort through the proposals to determine those that are viable and will create economic development.

Confirmation on the reappointment of William J. Wilhelm, Ph.D., Member, Kansas Technology Enterprise Corporation, term expiring January 15, 1999.

Dr. William Wilhelm, Dean, Department of Engineering, Wichita State University, stated he appeared before the Committee two years ago when he was first appointed to the KTEC Board. Dr. Wilhelm testified that he manages and oversees research programs at the University and is Director of the Center of Excellence. Dr. Wilhelm stated he serves on the Small Research Grant Committee and is able to share his assessment with other members of the Committee in approving grants. Dr. Wilhelm advised the grant applications reflect a greater awareness of KTEC and its various programs, as there are more grant applications and from more areas of the state. In response to the question where should the line be drawn and what action should be taken when employees of universities profit from the sale of products produced on university time with the assistance of university employees, undergraduate students and university laboratories, Dr. Wilhelm stated the individual should not be the beneficiary of profits. He stated the Board of Regents is quite aware of this potential and presently in the process of defining "conflict of interest". This question is raised often at the Board meetings. Relating to royalties, these are negotiated on a case by case basis.

Economic development efforts include work with the Ellis County Coalition for Economic Development, Hays Area Chamber of Commerce, and the Small Business Development Center to attract and grow businesses in our part of the state. Experiencing the other side of the economic development process, I was involved in internal negotiations that brought my current employer to Ellis County.

My present position is national marketing director of Wheelchairs of Kansas, a manufacturing firm that makes and distributes durable medical products for obese individuals. We've been successful in niche marketing for this very specialized group. This position has given me the opportunity to observe first hand how technology applies to manufacturing and to learn what MAMTEC has to offer. My company has also been assisted by Western Kansas Technology Corporation, the Center for Design, Development & Production, and KTEC's office of Innovation & Research.

Contributions

I can contribute a working knowledge of economic development, understanding of technology as it applies to my experiences, a private sector perspective, and many western Kansas business contacts. In addition, I can offer my knowledge of the marketing process: how to increase awareness, understanding and utilization of KTEC programs both in the state and throughout the country. Niche marketing, focusing on key constituencies, is a necessity in my job, KTEC also has a specialty niche which needs a special focus. My background working in and with small businesses can be viewed as an asset. I can also offer a business woman's perspective and enthusiasm for economic development efforts where technology is concerned.

Issues/Goals

As a board member representing the private sector, I'm concerned with accountability. In light of the Kansas Inc.
