Senator Langworthy made a motion to approve the minutes. Senator Harrington seconded the motion. The motion carried.

Senator Lawrence introduced the two candidates applying for the Board of Regents positions. Sylvia Robinson and Murray Lull.

Sylvia Robinson was born in Cedartown, Georgia. As a young child she attended elementary school in both France and Tacoma, Washington and later moved to Manhattan, Kansas where she attended junior high and graduated high school. Mrs. Robinson attended Kansas State University majoring and graduating in Elementary Education. She also has a Master's degree in education and Ph.D. in education/educational psychology and research from the University of Kansas. Mrs. Robinson is married to Roy L. Robinson, Sr. and they have two children together. A son, Roy, Jr. and a daughter, Cynthia. Mrs. Robinson has worked professionally as an elementary school teacher, an administrator, educational researcher, program evaluator and most recently a manager and program officer with the Ewing Marion Kauffman Foundation. A good portion of Sylvia's life has been her involvement in public service. Her service has been focused on issues related to the positive development of youth. She has served as a member of the Kansas City, Kansas Board of Education since 1983 where she has held office of President and currently Vice-president. In addition, she has served on many policy making boards advocating for youth. Mrs. Robinson stated that she was looking forward to serving on the Regents board (Attachment 1).

Senator Lawrence asked how she felt about the recent passage of the Qualified Admissions bill, **HB 2668**. Mrs. Robinson answered that she is opposed to the bill but will make an effort to help support the idea as best as she could.

Senator Jones stated that he was pleased to see Mrs. Robinson as one of the candidates, which is a constituent of his, and welcomed her.

Murray Lull is the president and CEO of The Smith County State Bank and Trust Company in Smith Center. He has been in the bank since 1972, after working for 2 1/2 years for the Federal Reserve Bank of Kansas City as an assistant bank examiner. Mr. Lull pointed out a few ways in which his bank is involved in education, examples which hopefully reflect his personal interest in the youth of the communities and their educations. The bank also makes uninsured educational loans to students and their parents, helping them pursue their education plans. The bank has also established and founded their own charitable foundation and have used a major part of the income from that foundation to set up a school/bank partnership. Mr. Lull has been involved in leadership positions in both the Kansas Bankers Association and the American Bankers Association over the past 15 years. He currently serves on the Governing Council of the KBA, the Board of Directors of the ABA and the ABA's budget committee, is chairman of the compensation committee, and is a member of the ABA's task force on rural development. His prime area of industry service currently is serving

as chairman of the ABA's task force on the future of the banking industry's payments system as it may be affected by electronic technological abilities being developed today. Mr. Lull believes that his background as a banker in finance, trusts and investments, student lending, rural development, and experience in leadership in the banking industry all lend themselves to his meeting the demands of being a member of the Board of Regents. Mr. Lull is especially interested in the budgetary and academic areas of the Board's array of responsibilities, but is most interested in the process of delivering a high-quality, immensely valuable education to the young people in the universities. Mr. Lull stated that it is an honor to have been appointed to the Regent's position by the Governor and would consider it a privilege to serve the State of Kansas (Attachment 2).

Senator Lawrence asked if Mr. Lull was aware of the major changes taking place in higher education. Mr.Lull answered that he was aware and that they need to adapt to the changes so that the demands are met and the services can be provided efficiently and effectively.

#### Madam Chair and members of the Senate Education Committee...

I am Murray Lull, president and CEO of The Smith County State Bank and Trust Company in Smith Center. I am the fourth generation in my family to serve as such, and have been in the bank since 1972, after working for 2 1/2 years for the Federal Reserve Bank of Kansas City as an assistant bank examiner. Our bank serves a population area of about 5,000 people in northcentral Kansas, and has total assets of \$60 million with an additional \$130 million in assets managed in our trust department.

While possibly not germane to what you want to know about me, I'd like to point out a few ways our bank is involved in education, examples which hopefully also reflect my personal interest in the youth of our communities and their educations. Our trust division has encouraged and provided the mechanism for 14 of our client trust accounts to pay out this year over \$126,000 in scholarships to 234 area students. And prior to the Federal Government's recently having had a better idea how to administer student loans, we were very active in the student loan business. We today still make uninsured educational loans to students and their parents, helping them pursue their education plans.

We've also established and funded our own charitable foundation and have used a major part of the income from that foundation to set up a school/bank partnership wherein we have provided funding for the purchases of roto-molding and milling equipment for our local high school's pioneering Technology Center. It's our thought that students will gain from the exposure and introduction to technologies they may later be using in real life.

Believing that service to one's industry is important, I've been involved in leadership positions in both the Kansas Bankers Association and the American Bankers Association over the past 15 years. I currently serve on the Governing Council of the KBA, the Board of Directors of the ABA and the ABA's budget committee, am chairman of the compensation committee, and am a member of the ABA's task force on rural development. Along with my ABA Board work, my prime area of

SENATE EDUCATION 3-25-96 ATTACHMENT 2 industry service currently is as chairman of the ABA's task force on the future of the banking industry's payments system as it may be affected by electronic technological abilities being developed today.

I believe my background as a banker in finance, trusts and investments, student lending, rural development, and my experience in leadership in the banking industry all lend themselves well to my meeting the demands of being a member of the Board of Regents. I also believe there are a number of parallels in the businesses of banking and education, most notably in the delivery systems of our products. Education and banking both have major investments in brick and mortar and personnel at a time when technology and the intergalactic internet and other electronic communications capabilities offer themselves as ways we might better connect with our students and customers.

Insofar as my prospective service to the Board of Regents, I am especially interested in the budgetary and academic areas of the Board's array of responsibilities, but I'm most of all interested in the amazing process of delivering a high-quality, immensely valuable education to our young people in our universities. We Kansans, especially in the rural areas, talk a lot about creating value-added products. In my mind the best value-added products we can deliver are our kids armed with educations that give them the opportunities in life that we all want for them and need them to have to continue the process of building and rebuilding our economic system.

In closing, I consider it an honor to have been appointed to this Regent's position by the Governor. Should you and the full Senate confirm this appointment, I would in every sense of the word consider it a <u>privilege</u> to serve the State of Kansas and the 81,000 university students as a member of the Board of Regents.
