SB 561 an act concerning elections; relating to contests of elections; costs

Senator Hardenburger opened hearings on the bill.

An amendment to the bill was read to the committee.

Senator Bond made a motion to pass the amendment on the bill. Senator Clark seconded the motion. The motion carried.

Senator Sallee made a motion to pass **SB 561** as amended. Senator Ranson seconded the motion. The motion passed.

Sen. Sub. for Sub. HB 2079 an act concerning elections

Senator Hardenburger opened hearings on the bill.

The committee discussed at length the conflicting terminology in amendments of this bill and that of <u>SB 397</u> that has already been passed out of committee. Senator Bond expressed the importance of the NVRA package being accurate and reflecting the intention of this committee.

There was also discussion about the need to more strictly define the reasons for the stiff penalty for a person or an agency to make a profit on the amount of voter registraton cards turned in. The Office of Secretary of State felt the need to add this section to avoid flooding the system with a lot of duplicate cards and cards submitted with false information.

Due to it's confusing language, Senator Hardenburger asked the committee to study the new bill and stated that hearings would remain open.

The meeting adjourned at 2:20 p.m.
