HB 2602 - SPEED LIMITS

The Chairman opened the meeting for several items of discussion on this legislation. Senator Papay expressed strong feelings for keeping the bill "clean". Senator Brady voiced concern for county roads and county officials and suggested that they be allowed the same guidelines as the Secretary of Transportation.

Senator Rock offered a conceptual motion to allow Township and Counties not to post speed limits unless they are over 55 mph. Senator Papay seconded this.

Senator Rock then asked to amend Section 3 and 4 to change the "buffer" back to the 10 mph. This was seconded by Senator Harris. Motion carried.

Senator Harris made a motion to amend the bill from 70 mph to 75 mph. This was seconded by Senator Lawrence. Motion failed.

A motion was then made by Senator Rock to pass this bill as amended. A seconded was made by Senator Harrington and the motion carried.

The Chairman asked the committee to introduce a bill draft for front license plates. A motion was made by Senator Harrington to have this legislation introduced. A seconded was made by Senator Jordan. Motion carried.

A motion was then made by Senator Lawrence to approve the minutes of the February 8th meeting. Senator Harrington seconded this. Motion carried.

The meeting was then adjourned by the Chairman at 10:40 a.m.
