The committee heard from Teachers Talking about Technology.

Cyndi Harrison, Trailwood Elementary School, Shawnee Mission, commented that teachers use technology in every aspect of teaching. "There is a great disparity between classrooms and schools in the same district."

Deliece Mullen, Kathryn O'Loughlin McCarthy Elementary School, Hays, stated that there is a need to "get back to basics", but computers have become a tool for children to learn while they are having fun. "Technology is empowering children."

Kay Barkis, Louisburg Elementary/Middle School, Louisburg, explained that computers help those who can't focus by holding their attention with color and programs that are not only educational but fun.

Jamie Hofmeier, Heusner Elementary School, Salina, stated that computers give those who can't speak a voice.

Mickey Bogart, Manhattan High School, Manhattan, told the committee that direct access to the internet allows students to compare stories in newspapers with other states and countries. "Technology broadens a students outlook."

Phyllis Zielke, West Elementary School, Goodland, commented that technology gives oxygen to education by getting teachers, parents, & children excited about education.

Becky Goodwin, Kansas State School for the Deaf, Olathe, told the committee that students are actually excited about coming to school because they get to work on computers.

JoAnn Schuette, Curtis Middle School, Wichita, explained that technology helps children learn math when they can "play" games on computers that deal with math.

Norman Conard, Uniontown High School, Uniontown, stated that his students believe that "electronics is a campfire; you can feel the warmth of learning."

HB 2098 - School districts, enrollment and transportation of nonresident pupils

Representative Aurand made a motion to report HB 2098 favorably for passage. Representative Morrison seconded the motion.

Representative Aurand made a motion to insert on page 1, in line 18, after "district" "other than a school district all or any part of which is located in Johnson county, Sedgwick county, Shawnee county or Wyandotte county; in line 21, after "district" by inserting, "other than a school district all or any part of which is located in Johnson county, Sedgwick county, Shawnee county or Wyandotte county," Representative Morrison seconded the motion. The motion carried.

Representative Larkin made a motion that would define "a school district as one that is in the State of Kansas." Representative Reardon seconded the motion. The motion carried.

Representative Aurand made a motion to report **HB** 2098 favorably for passage as amended. Representative Franklin seconded the motion. The motion carried. Representative Powers requested that he be recorded as voting no.

Chairman O'Neal assigned the following representatives to serve on a sub committee on HB 2091: Ballou, Tanner, Horst, Storm & Toelkes.

Representative Morrison made a motion to approve the committee minutes from January 27, 28, 29, 30, February 3, 4, 5, & 10. Representative Horst seconded the motion. The motion carried.
