Chair explained that the House has a new procedure this year as it relates to the implementation of a Fiscal Oversight Committee whose chairman is Rep. Carl Holmes. To give you a feel of how significant this issue of fiscal notes is, when we get to the end of the session, and by law the last bill is the budget bill, we will need to rectify these numbers. The determination of a fiscal note has dramatic implications as to how it relates to policy. Chairman Holmes will tell us how the committee works. We will be reviewing all the fiscal notes relating to bills this committee has heard and if there are any objections, we will take it before the Fiscal Oversight Committee for more clarification.

Bill Introduction

Moved by Rep. Powell, seconded by Rep. Donovan, introduction of a bill concerning altering the definition of public utilities to exclude electric generators, both equipment and business that controls it. Motion carried.

Following the explanation of the goals of the Fiscal Oversight Committee by Chairman Holmes, the committee reviewed fiscal notes on thirty nine bills in the Taxation Committee. (Attachment 1) Objection made on the following fiscal notes by the person named:
