## SB 387 - Transfer of workplace health and safety to department of human resources

Jeff Wagaman, Deputy Secretary, Department of Administration, testified that SB 387 transfers the Workplace Health and Safety Program from the Department of Administration to the Department of Human Resources. The transfer utilizes the expertise of the Workers Compensation staff who presently conduct health and safety programs for private industry and to ensure State employees are adequately trained in health and safety matters in the workplace. Mr. Wagaman stated the Department of Administration is presently negotiating with the Department of Human Resources for the transfer which consists of two full-time employees in an amount of approximately \$172,000.

Phillip S. Harness, Director, Workers Compensation Division, testified the transfer of training personnel is acceptable to the Division; and he feels confident that the program can be conducted more efficiently and effectively with the available personnel.
