MINUTES OF THE SENATE ELECTIONS AND LOCAL GOVERNMENT COMMITTEE.

The meeting was called to order by Chairperson Janice Hardenburger at 1:40 p.m. on February 11, 1997 in Room 529-S of the Capitol.

Chairperson Hardenburger asked for approval of the Minutes of February 5 and 6, 1997.

Senator Gooch moved to approve the minutes. Senator Steineger seconded the motion. The motion carried.

Chairperson Hardenburger opened the hearing on **SB** 116.

SB 116 Concerning records open to the public; relating to the access of certain material

Senator Clark appeared before the committee in support of the bill. He testified that this bill was introduced at the request of a number of county commissioners from his district and submitted copies of letters from those county commissioners requesting legislative action to prevent these records from being used for fund-raising efforts (Attachment 1). An agency had requested names of owners of homes valued over \$50,000 in 23 counties to use for a direct mail campaign to raise funds. He stated 12 of these counties are in his Senate district.

There was committee discussion about inserting a penalty clause in to the current statute (K.S.A.45-220).

Chairperson Hardenburger closed the hearing on the bill.

Senator Praeger moved to amend the bill to include a misdemeanor penalty. Senator Vidricksen seconded the motion.

There was more discussion on who would be penalized if the statute was violated.

<u>Senator Vidricksen made a substitute motion to pass the bill out favorably as written. Senator Praeger seconded the motion.</u> Upon request by the Chairperson, a voice vote was taken. The vote was 4-3 in favor of the bill. The motion passed.

Chairperson Hardenburger opened the hearing on **SB** 133.

SB 133 Concerning certain counties; relating to planning and zoning

Staff gave an overview of the bill stating this bill would eliminate the 60-90 day comment period currently required by "urban counties" in the state in regard to planning and zoning changes. Johnson County is the only county in the state designated an "urban county".

Joyce Coker, Intergovernmental and Community Relations Coordinator for Johnson County, appeared in support of the bill. She testified that Johnson County is the only county in Kansas with this statute and asked for Johnson County laws to be consistent with the time requirements for all other counties in the state to providing a 20-day notice of public hearing to consider amendments to comprehensive plans, zoning

regulations, and subdivision regulations ($\underline{Attachment 2}$).

Chairperson Hardenburger closed the hearing on the bill.

<u>Senator Vidricksen made a motion to pass the bill out favorably. Senator Steineger seconded the motion. The motion passed.</u>

The meeting was adjourned at 2:20 p.m.



TESTIMONY BEFORE THE SENATE ELECTIONS AND LOCAL GOVERNMENT COMMITTEE

SENATE BILL NO. 116 February 11, 1997

Madam Chair and members of the Committee:

The current Kansas Open Records statute prohibits:

- 1. The person that acquires a list of names and addresses under this statute from using this list for a commercial purpose to sell goods and services.
- 2. Selling or giving a list of names and addresses to another person who would use the list to sell goods and services.

Senate Bill 116 adds a third prohibition to this list. This bill prohibits the use of this list for the purpose of solicitation of gifts or donations. Last year the Director of Property Valuation received a request from a charity for a list of the names and address of all property owners in 23 counties that owned property valued at \$50,000 or more for the purpose of a holiday direct mail campaign. The request asked that the information be provided on computer disk in ASCII format. PVD provided this information at a cost of \$34 total, not \$34 per county, but \$34 for all 23 counties. 12 of the counties happen to be in my legislative district and many of the county commissioners contacted me about changing the law because they and I feel this is an improper use of property valuation records and should not be used to create mailing lists for solicitation.

I have attached a copy of the letter of request from the nonprofit organization, several letters from county commissioners. I would ask that you move this bill out favorably and would be glad to answer any questions.



Gentlemen:

Enclosed is a copy of a letter our county received from the American Red Cross at Lawrence, indicating to us that the American Red Cross is going to be using property owner records in a number of counties in Kansas to develop a direct funds solicitation for their organization. It is our understanding that PVD has provided these records to the American Red Cross for all 23 counties at a cost of \$34 total; not \$34 per county but \$34 for all 23 counties.

We think that the use of these lists for funds solicitation is not what the Legislature intended public records to be used for. Currently the Open Records prohibition does not allow people to use public records for purposes of selling goods or services, or solicitation for sale of goods or services; but, there is nothing in the statute right now that prohibits, as near as we can tell, a solicitation for charitable giving.

While certainly the American Red Cross is a very worthwhile charity, we think it is objectionable to use public records for the purpose of solicitations and fund-raising. We would respectfully request that you review this letter and attempt to have legislation adopted in the next session of the Legislature which would close this loophole.



Senate Elections and Local Government Committee Testimony regarding SB 133 February 11, 1997

Submitted by Joyce Coker, Intergovernmental and Community Relations Coordinator for Johnson County

Madam Chairwoman and members of the committee, my name is Joyce Coker, Intergovernmental and Community Relations coordinator for Johnson County. I am representing the Johnson County Board of Commissioners today to ask you to consider a procedural change as described in SB 133.

As the only county in Kansas designated an "urban county," Johnson County follows a unique state statute (K.S.A. 19-2958) that governs the procedure the county must use to notify the public before amending its comprehensive plan and zoning regulations. State statue for "urban counties" currently requires that Johnson County provide a 60- to 90-day comment period--the only county in the state required to do so. Johnson County would like to eliminate this comment period so that the amount of time required to pass an amendment is consistent with the time required for all other counties and cities in Kansas.

Presently, cities and counties in Kansas, including Johnson County, must provide a 20-day notice of public hearing to consider amendments to comprehensive plans, zoning regulations, and subdivision regulations. We believe this is ample time. After the Planning Commission makes a recommendation, however, Johnson County is the only county required to wait an additional 60 to 90 days before the County Commission can act

Because the county believes it is important to notify neighboring entities and interested parties so they are able to provide feedback on changes being considered, the county shares agendas of upcoming commission meetings with neighboring jurisdictions and frequently sends advance copies of staff reports and applications to neighboring cities when an issue will affect them. Our Planning Director Roger Kroh, who is here with me today to help answer questions, has consulted with city administrators or planning directors of the cities that abut our unincorporated area. None of them object to our proposed elimination of the 60- to 90-day comment period because the county and cities all continue to exchange agendas and notices.

We believe that eliminating the 60- to 90-day comment period in a manner consistent with the time requirements for other counties in Kansas would allow Johnson County to streamline its notification/ amendment procedure and eliminate delays for both the county and for its developers and other citizens.
