The Chairperson introduced the staff and briefed the committee on the procedures of the Committee on Energy & Natural Resources.

Janet Stubbs appeared representing the Kansas Building Industry Association, a trade association with a membership of approximately 1200 companies in the residential and light commercial construction industry.

The Kansas Building Industry Association requested the re-introduction of a bill which passed the House of Representative in 1996 by a vote of 114 to 10 and was then amended by the Senate but failed to receive agreement by a conference committee. The bill would contain the same provisions as
HB 2707 as amended by the House Committee of the
1996 Session.">1996 Session. (Attachment 1)

This bill would remove the authority of the Kansas Corporation Commission to adopt a statewide energy code for Kansas residential building construction and would retain the authority of local units of government to adopt and enforce building codes, if they deem it necessary.

The spokesperson for the Kansas Building Industry Association request introduction of this legislation.

Senator Morris, with a second from Senator Huelskamp moved to introduce the bill. The motion carried.

Chairperson, Senator Sallee requested to introduce the bill dealing with freon, also considered by the 1996 Legislature. Senator Tyson, with a second from Senator Huelskamp, moved to introduce the bill. The motion carried.

James J. O'Connell, Secretary, Kansas Department of Health and Environment, appeared before the committee to present a brief report on Nebraska reviewing an application for citing of a low level radioactive waste depository. Other subjects reviewed were Surface Water Quality and Groundwater Quality. He noted Groundwater Quality is the big issue at this time. Another high priority item is Public Water Supply. A final issue mentioned by the Secretary was the issue of ozone and air quality in the Kansas City metropolitan area.

The meeting adjourned at 9:00 a.m.

The next meeting is scheduled for January 21, 1997.

My name is Janet Stubbs appearing today representing the Kansas Building Industry Association, a trade association with a membership of approximately 1200 companies in the residential and light commercial construction industry.

HOUSE BILL No. 2707

AN ACT concerning building energy efficiency standards; amending K.S.A. 66-131a and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 66-131a is hereby amended to read as follows: 66-131a. (a) Except as provided by subsection (b), every municipally owned or operated electric or gas utility; and every electric or gas utility operating wholly and solely within the legal boundaries of any municipality and within three (3) miles of any municipal boundary, shall be deemed a "public utility" as defined in K.S.A. 66-104 and amendments thereto, for the purpose of filing with the state corporation commission tariffs and rules and regulations restricting connections or attachments to their systems of residential, commercial or industrial structures with respect to such heat loss standards and energy efficiency ratios for air conditioners and heat pumps as the state corporation commission shall from time to time adopt structures that do not comply with the energy efficiency standards required for such structures under the federal energy policy act of 1992.

(b) The state corporation commission does not have authority to adopt or enforce energy efficiency standards for:

(1) Any commercial structure located in a city or county that has adopted and in effect energy efficiency standards for commercial structures that meet the minimum standards required for such structures under the federal energy policy act of 1992; or

(2) any residential structure.

Sec. 2. K.S.A. 66-131a is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the statute book.
