#### MINUTES OF THE HOUSE COMMITTEE ON ECONOMIC DEVELOPMENT.

Chairman Mason opened the hearing on **HR 6008** - a resolution urging the Department of Commerce and Housing to seek the establishment of a World Trade Center in the Kansas City area.

Speaker Shallenburger briefed the committee on the resolution introduced last session. (No written testimony) He explained the reason for the resolution is to stress the importance of international trade to Kansas. He said that a concerted effort should be made to ensure that Kansas City, the part of the state that is growing the most, has an emphasis on International trade. The state of Kansas should do what it can as partners with those businesses dealing with foreign trade.

Sheila Devine, Dept. Of Commerce & Housing clarified that the resolution asks the Kansas Department of Commerce & Housing to conduct a study assessing the possibility of establishing a world trade center in the Kansas City metropolitan statistical area. She presented information from a preliminary review (Attachment 1). In order to create of WTC, an application must be made to the WTCA for a charter. The cost of the charter is \$200,000, plus annual dues of \$9,000. There can be one WTC within one city or economic region. A WTC already exists in Kansas City, through The Greater Kansas City Area Chamber of Commerce offices. Due to the geographic territory of its regular members the WTCA specially prohibits setting up another WTC in that City. International trade services are available to Kansas companies in the metropolitan Kansas City area from the KS Department of Commerce & Housing, from the WTC operated by the Greater Kansas City Area Chamber of Commerce, and from many private sector companies. It is the belief of the KS. Dept. Of Commerce and Housing that the International business needs of Kansas companies are being served by these existing service providers.

Agnes Otto, The Greater Kansas City Chamber of Commerce, gave an overview of the Chamber's International Plan (<u>Attachment 2</u>). Included are the Mission Statement, International Motto, 97 Progress, 7 Objectives and Tactics, Budget, Funding and International Investors.

General discussion followed, covering questions and answers related to the following issues: WTC parent company, purpose of the resolution, unmet needs, specific territorial boundary, length of time in Charter, Budget and the relationship between the Kansas City and Wichita offices.

#### Chairman Mason closed the hearing on HR 6008.

Representative Beggs moved that the minutes from the February 23 meeting be approved. Representative Sharp seconded the motion and the motion carried.

Chairman Mason adjourned the meeting at 4:15 p.m.

The next meeting is scheduled for March 11.

## TESTIMONY BEFORE THE HOUSE ECONOMIC DEVELOPMENT COMMITTEE

#### THE KANSAS DEPARTMENT OF COMMERCE & HOUSING TRADE DEVELOPMENT DIVISION SHEILA G. DEVINE, DIRECTOR 10 MARCH 1998

I would like to thank the Committee for this opportunity to present information regarding House Resolution 6008. This resolution asks the Kansas Department of Commerce & Housing to conduct a study assessing the possibility of establishing a world trade center in the Kansas City metropolitan statistical area. We have already conducted a preliminary review of this issue and would like to share with the Committee our findings.

In order to create a World Trade Center, one must apply to the World Trade Centers Association (WTCA) for a charter. Charters are approved by the WTCA Board of Directors. The cost of the charter is \$200,000. In addition, one must pay annual membership dues of \$9,000. One is then considered a Regular Member. (Those are current fees, subject to change.)

The WTCA does provide some geographic protection or "territory" for its Regular Members. An additional World Trade Center cannot be established within "any one city or economic region."

A chartered World Trade Center already exists in Kansas City. The Greater Kansas City Area Chamber of Commerce operates that facility from its offices. (See web page, copy attached.)

If the demand for services is very great, however, a "satellite" world trade center can be established in the existing member's territory. The application for a satellite center must be submitted by the existing Regular Member. However, the by-laws of the WTCA state that a Satellite center can only be established if the existing World Trade Center is located in its own World Trade Center building/complex. The World Trade Center run by the Greater KC Area Chamber of Commerce is not located in its own World Trade Center building or complex; therefore, a satellite center is not an option.

We appreciate the Legislature's interest in supporting international trade; however, the WTCA specifically prohibits setting up another World Trade Center in the same city or economic region as an existing center. We do not see this as having a negative impact on Kansas companies. International trade services are available to Kansas companies in the metropolitan Kansas City area from the Kansas Department of Commerce & Housing, from the World Trade Center operated by the Greater Kansas City Area Chamber of Commerce, and from many private sector companies. In 1997, the Kansas Department of Commerce & Housing alone worked with almost 200 companies in the seven Kansas counties of the metropolitan statistical area. We believe that the international business needs of Kansas companies are being served by these existing service providers.
