## KANSAS COMMISSION ON GOVERNMENTAL STANDARDS AND CONDUCT

## Testimony before Senate Elections and Local Government in Support of Senate Bill 451 by Carol Williams

Senate Bill 451 amends K.S.A. 25-4161 and K.S.A. 46-256 which are provisions in the Campaign Finance Act and the Governmental Ethics Laws. This bill is a recommendation made by the Kansas Commission on Governmental Standards and Conduct in its 1997 Annual Report.

Under current law, the Commission is authorized to notify the Attorney General of any apparent violations of criminal law or other laws not administered by the Commission, which might be discovered during a Commission investigation.

This bill would allow the Commission to be able to notify any federal or local authorities, besides the Attorney General's office, of violations of laws outside the Commission's jurisdiction which are discovered during a Commission investigation.

For a possible violation of federal election law which may be discovered during a Commission investigation, the Commission would like to be able to go directly to the Federal Election Commission with its discovery, rather than having to turn it over to the Attorney General's Office for that office to refer the discovery over to the Federal Election Commission. Eliminating the Attorney General's Office as an intermediary would speed the process of getting necessary information to the agency, either federal of local, that would ultimately be responsible for the violation.

The Commission urges the Committee's support of SB 451.
