KANSAS COMMISSION ON GOVERNMENTAL STANDARDS AND CONDUCT

TESTIMONY BEFORE SENATE ELECTIONS & LOCAL GOVERNMENT IN SUPPORT OF SB 480 By W. Charles Smithson, Legal Counsel

SB 480, which is before you this after, amends the Campaign Finance Act, the state level conflict of interest laws including the lobbying provisions and the local level conflict of interest laws.

This bill amends all relevant statutes so that the "Kansas Commission on Governmental Standards and Conduct" becomes known as the "Governmental Ethics Commission".

This bill makes it easier for people to find us in the telephone book and just in general makes more sense. From 1974 until 1981, this was the name of the Commission. From 1981 until 1990, the Commission was known as the "Kansas Public Disclosure Commission". In fact, the spouse of a Commission employee still thinks the name of the agency is the "Public Disclosure Commission".

There are also some technical cleanups throughout the bill such as removing an "or" and moving a "shall".

The Commission supports the favorable passage of this bill and would, of course, like to see it on the Consent Calendar.
