Request for Introduction Senate Public Health and Welfare Committee

February 2, 1998

The Honorable Senator Sandy Praeger, Chairperson and Honorable Members of the Senate Public Health and Welfare Committee:

The members of the Kansas Academy of Physician Assistants request introduction of legislation to modify the present registration process for a Physician Assistant to licensure.

There are 280 Physician Assistants ("PA") currently registered in Kansas with the State Board of Healing Arts. PAs serve an important role, as an extension of their responsible physician and as health care providers. In many cases, the PA is the only source of basic health care available on a daily basis, particularly in rural areas.

A Physician Assistant can perform a wide range of medical duties, from primary family medicine to high-technology specialties, such as medical research. All of these duties, whether performed in a hospital, clinic or private physician office, are done under the direction and supervision of a responsible physician, or physician approved protocols.

The history of the Physician/PA team relationship has always been one of dependent practice with a supervising physician. Changing to licensure does not indicate a push toward independent practice. PAs remain committed to practicing in a dependent role with physician supervision. Physician Assistant licensure will not create any change in the current scope of practice for a PA, nor does it hinder other practitioners in the performance of their duties.

By seeking a transition from registration to licensure, PAs are actually asking for more rigid oversight. Licensure would provide the Kansas State Board of Healing Arts with greater ability to regulate the acts and practices of a Physician Assistant. A move from registration to licensure will insure that Kansans receive the highest quality of health care by holding PAs to the most rigorous form of regulation and appropriately high standards. Licensure would improve the public's access to care, and improve the physician's ability to efficiently utilize Physician Assistants as apart of a health care team.

As an extension of their responsible Physician, PAs should be held to the same regulatory standard. Licensure, as a form of regulation for Physician Assistants, allows the State of Kansas to keep pace with the evolving and expanding role that Physician Assistants fulfill as a members of an important medical practice team.

Proposed licensure legislation provides and accomplishes:

Clean up references to "Physicians' Assistants" to "Physician Assistant".

Qualification for License - provides Kansas Board of Healing Arts with ability to gather more information.

Revocation of License - provides Kansas Board of Healing Arts with defined grounds for disciplinary action .

Temporary License - provides for expiration and clear cut action by Kansas Board of Healing Arts.

Scope of Practice - clearly defines the dependent role of the Physician Assistant with a Responsible Physician and the services provided.

Definition of Supervision - provides for supervision at remote sites, essential for rural communities.

Defines and excludes certain care givers from provisions of act.

Professional conduct - requires quality, professional care from PA.
