House Bill 2621 comes from a request by a local non-profit organization in Arkansas City. The Arkansas City Beautification Committee is working with Kansas State University and many local groups in Arkansas City for the development of parks and recreation areas along the recently opened by-pass around the east side of Arkansas City. Much of this land sits in the flood plain of the Walnut River which limits development.

The Arkansas City Beautification Committee requested a name for the bypass and asked me for legislation. I requested the Committee to first ask for a resolution by the City of Arkansas City for the naming of the road. The City of Arkansas City took the matter up and also requested the naming of the by-pass to be the Walnut Valley Greenway.

Upon return to the legislature this session, I submitted HB 2621. In the House Transportation Committee, I requested an amendment to correspond with the re-numbering of U.S. 77. The House Committee amended the bill to return the Robert B. Docking Memorial Highway to downtown Arkansas City (New Business U.S. 77).
