


#### FY 1999



The Regents approved a plan for enhancement of the present equipment base, featuring: (1) a tuition increase of \$1 per credit hour; (2) a request for state matching of \$2 per student credit hour; and (3) a request for one-time program initiation funding of \$12 million. The Governor approved the Regents request for tuition and state match. Additionally, he recommended \$5 million for one-time program initiation funding. Major areas for equipment improvement are:

- Updated Audio-Visual Classroom Equipment
- Increased Availability of Personal Computing For Students
- Increased Availability of Personal Computing For Faculty
- Updated Laboratory Equipment In the Sciences
- Improved Computing Networks Within Each Campus
