Rep. Rehorn made a motion to amend by striking on page 1, lines 38-40 "The name of a firm may not include the name of an individual who is not a certified public accountant if the title "CPA" is included in the firm name." It was seconded by Rep. Humerickhouse. The motion to amend passed.

Rep Grant made a substitute motion to pass the bill out favorably as amended. The motion was seconded by Rep. Long. The motion carried.

Final Action on: HB 2354 - Certified public accountants; CPA designation.

Rep Humerickhouse made a motion to table the bill. Rep. Ruff seconded the motion. The motion passed and HB 2354 was tabled.

Final Action on: HB 2353 - Certified public accounts; late renewals and reinstatement.

A motion to table the bill was made by Rep. Humerickhouse. Rep. Ruff seconded the motion. The motion passed and **HB 2353** was tabled.

Chairman Lane announced the committee agenda for next week and then adjourned the meeting at approximately 9:30 a.m.

The next meeting is scheduled for March 4, 1999.
