The minutes of the February 16<sup>th</sup> meeting were approved on a motion by Senator Bond, seconded by Senator Vratil. Carried.

Judiciary Subcommittee Chairs reviewed a number of their assigned bills. The following action was taken:

SB 446-Kansas administrative procedure act; abuse, neglect or exploitation of adults; regarding investigation by KDHE

SB 448-concerning docket fees

SB 505-crime victims restitution; regarding compensation

SB 529-concerning corporations; regarding execution of certain documents

<u>SB 446</u> - <u>Senator Vratil moved to pass the bill out favorably as recommended by subcommittee, Senator Bond seconded.</u> Discussion. Carried with Senator Pugh voting nay.

SB 448 - Senator Vratil moved to pass the bill out favorably as recommended by subcommittee and place it on the consent calendar, Senator Pugh seconded. Discussion. Carried with Senator Feleciano voting nay.

<u>SB 505</u> - <u>Senator Vratil moved to amend the bill on the recommendation of subcommittee to delete entirely the prohibition from paying such crime victims compensation claims to corporations and other business entities, thus allowing any county to do so and pass it out favorably as amended, Senator Goodwin seconded.</u>

<u>SB 529</u> - <u>Senator Vratil moved to amend the bill on the recommendation of subcommittee to include a provision that sets a procedure for an existing Kansas corporation to convert to a holding company structure in which the existing Kansas corporation becomes a wholly owned operating subsidiary of a new Kansas holding company and pass the bill out favorably as amended, Senator Goodwin seconded. <u>SB 578</u> - Senator Pugh moved to pass the bill, Senator Vratil seconded. Following discussion both senators withdrew their motions and no further action was taken on the bill at this time.

<u>SB 585</u> - <u>Senator Pugh moved to pass the bill out favorably as recommended by the subcommittee, Senator Donovan seconded. Carried.</u>

<u>SB 488</u> - <u>Senator Pugh moved to pass the bill out favorably as recommended by the subcommittee, Senator Goodwin seconded.</u> Carried.

<u>SB 485</u> - <u>Senator Pugh moved to pass the bill out favorably as recommended by the subcommittee, Senator Feleciano seconded. Carried. (attachment 2)</u>

SB 559-concerning electronic transfers

SB 559 - Senator Goodwin moved to amend the bill by striking the language on page 2 at line 22 beginning with "The" and all of lines 23 and 24 and beginning on page 8, all of sections 17,18, and 19 as recommended by the subcommittee and pass the bill out favorably as amended, Senator Vratil seconded. Carried. (attachment 3)

SB 370 - Following discussion on the bill, there was general consensus to take no action at this time.

SB 461 - Senator Oleen moved to amend the bill to include Conferee Judge Graeber's recommendations and to pass the bill out favorably as recommended by the subcommittee, Senator Vratil seconded. Carried.

SB 490, 491, 546, and 583 - Following discussion Committee decided to revisit these bills on 2-22. (attachment 4)

<u>SB 386</u> - Following discussion Senator Goodwin moved to amend the bill to delete "computer crime" and replace it with "any crime involving a computer" as recommended by the subcommittee and pass the bill out favorably, Senator Vratil seconded. Carried with Senators Harrington, Donovan, Pugh, and Petty voting nay.

<u>SB 384</u> - following discussion, it was the consensus of the Committee to take no action on the bill at this time. (attachment 5)

# Senator Vratil's Judiciary Subcommittee

The Subcommittee met on February 14, 17 and 18, 2000. The Following is a brief summary of the subcommittee's hearings and recommendations.

(1). <u>Senate Bill No. 446</u>: Provides that hearings, findings, evaluations and actions taken by the Kansas Department of Health and Environment regarding reports of abuse, neglect or exploitation of adults in adult care homes and other facilities be conducted in accordance with the Kansas Administrative Procedures act rather than rules and regulations of the secretary of Health and Environment.

Proponents: Bill Rein, KDHE

Opponents: None

Subcommittee Action: Recommendation that the bill be passed favorably by the full

committee.

(2). <u>Senate Bill No. 447</u>: Would eliminate certain requirements relating to issuance of subpoenas of business records. Specifically, the notice of issuance of the subpoena to all parties 10 days prior to the issuance of the subpoena and the notice of receipt of the business records by the clerk of the district to the party requesting such records would be eliminated.

Subcommittee Action: Recommendation that the bill be amended to not delete the notice

requirement relating to notice of issuance of subpoena 10 days prior to such issuance but clarify that the notification requirement is the responsibility of the party requesting the subpoena and not the clerk of the district court. The subcommittee recommends the bill be passed favorably as amended by the full committee.

In god 2-21-10 att 1 (3). <u>Senate Bill No. 448</u>: Increase docket fee for actions involving violations of nonmoving traffic regulations from \$45 to \$46. Current law already provides a docket fee of \$46 for actions involving violations of moving traffic violations.

Subcommittee Action: Recommendation that the bill be passed favorably by the full

committee.

(4). <u>Senate Bill No. 483</u>: Changes to law relating to the secretary of state's duties to serve process on business entities. Specifically, the bill provides a uniform standard of service of process whenever the resident agent cannot be located; service may be made on the secretary by certified mail or personal service; inclusion of limited liability companies to service of process statute; and waiver of service of process fee for state agencies.

Subcommittee Action: Recommendation that the bill be amended to make technical

amendments to better clarify changes in the service of process statute and the limited liability company act related to service of process. The subcommittee recommends the bill be passed

favorably as amended by the full committee.

(5). <u>Senate Bill No. 505</u>: Allows claims for crime victims compensation to be paid by local crime victim compensation boards, in counties having a population of less than 10,000 to corporations or other business entities as long as money does not come from a government source. Most of the amendments in the bill are a reconciliation of conflict of law.

Subcommittee Action: Recommendation that the bill be amended to delete entirely the

prohibition from paying such crime victims compensation claims to corporations and other business entities, thus allowing any county to do so. The subcommittee recommends the bill be

passed favorably as amended by the full committee.

(6). <u>Senate Bill No. 529</u>: Eliminates the requirement that corporate documents be acknowledged (notarized) and provides as with other business entities (LL Cos, LP/s and LLP/S) that execution is accomplished by signing such documents under penalty of perjury.

Subcommittee Action: Recommendation that the bill be amended include a provision that sets a procedure for an existing Kansas corporation to convert to a holding company structure in which the existing Kansas corporation becomes a wholly owned operating subsidiary of a new Kansas holding company. The subcommittee recommends the bill be passed favorably as amended by the full committee.

(7). Senate Bill No. 582: Reverses action of the 1999 legislature relating to requiring a review of plats and surveys by a county surveyor or engineer and in the absence of either, the county could contract with a private surveyor to complete the review. This bill would take the law back prior to the 1999 changes.

(8). Senate Bill No. 595: Amends criminal stalking statute to include stalking by electronic means to deal with cyberstalking.

Subcommittee Action: Recommendation that the bill be passed favorably by the full committee in lieu of Section 1 of 2000 Senate Bill No. 384 which creates the crime of electronic harassment.

(9). Senate Bill No. 429: Provides that for drivers under 21 whose blood alcohol content is .08 or greater their period of suspension will be one year like those whose blood alcohol content is between .02 and .0799 rather than some period of suspension less than one year (i.e. the term of a diversion agreement or 30 days as one court did).

Subcommittee Action: Recommendation that the bill be passed favorably by the full

committee.

(10). <u>Senate Bill No. 629</u>: Eliminates requirement that reconciliation of capital accounts of certain organizations be included on annual report and requires the secretary of state to not disclose the amount of franchise tax paid by a business entity.

Subcommittee Action: Recommendation that the bill be amended to include limited partnerships in the provisions of the bill and delay the effective date until January 1, 2001.

# SENATOR PUGH'S JUDICIARY SUBCOMMITTEE (February 14 and February 17)

SB 224 clarifies the law regarding corner inquests to provide this bill in the county where
the death occurred rather than where the cause of death occurred and requires filing of
the coroner's report in the county where the death occurred, if known. Otherwise, where
the dead body was found.

2. **SB 480** allows counties between 25,000 and 100,000 population to require the county attorney to devote full time to official duties and requires the salary for this office to be not less than 70 percent but not exceed the salary of a district judge.

3. **SB 485** provides that a variety of contractual arrangements including beneficiary designations in individual retirement accounts shall be regarded as nontestamentary in nature.

4. SB 488 amends the sentencing guidelines law to clarify the law in a multiple conviction case when a defendant has the primary crime conviction reversed on appeal. The bill provides that the second most serious crime becomes the basis for determining the sentence in regard to prior criminal history.
