Introduction of bills

Larry Froelich, Executive Director, Board of Pharmacy, requested the Committee introduce legislation that would change the Pharmacy Practice Act to allow for registration of the Kansas State College of Veterinary Medicine Pharmacy from the Kansas Board of Pharmacy. (Attachment 1) Senator Salmans made a motion the Committee introduce the proposed legislation, seconded by Senator Becker. The motion carried.

Mary Lou Davis, Executive Director, Board of Cosmetology, requested the Committee introduce legislation that would update the statutes relating to fees, student instructors, out-of-state licensure applications, and recognition of another state's disciplinary action against a Kansas licensure applicant or licensee. (Attachment 2) Senator Salmans made a motion the Committee introduce the proposed legislation, seconded by Senator Langworthy. The motion carried.

Annual Report of Health Care Data Governing Board

Elizabeth Saadi, Ph.D., KDHE, presented the Health Care Data Governing Board's 1999 Annual Report as required by K.S.A. 65-6807. The Health Care Data Governing Board was created in 1993 to guide development of the Kansas Health Care Database at KDHE and to provide a forum for discussion of health information issues. Highlights of Dr. Saadi's presentation to the Committee included: Appointment of Senator Sandy Praeger as Chair of the Health Care Data Governing Board, collaboration with evaluation of the HealthWave Program, increasing awareness in collecting external cause of injury data in hospital discharge data systems, contributing to the Kansas Health Statistics newsletter to disseminate information, capacity improvements, solidified partnerships with credentialing boards, and beginning the dialogue to collect health services utilization data as outlined in her written testimony. (Attachment 3) Copies of the Health Care Data Governing Board Annual Report can be obtained from the Kansas Department of Health and Environment. During Committee discussion, the Chair introduced Robert Day, a member of the Governing Board and Director of Medical Policy and Medicaid at SRS who expressed his support for collaborative efforts between the two agencies.

The Kansas Board of Pharmacy respectfully requests the committee's support in adoption of changes to the Kansas Pharmacy Practice Act.

The request for the change to the Pharmacy Practice Act will allow for registration of the Kansas State College of Veterinary Medicine Pharmacy from the Kansas Board of Pharmacy. With the current list of categories, there is no correct "fit" for this particular pharmacy setting.

A task force of the Board was developed after the Dean of the College, Dr. Ralph Richardson, approached the Board. We have currently been issuing this location a registration for an "Institutional Drug Room". When reviewing the definition of this category, it does not include this type of pharmacy setting.

PROPOSED STATUTORY CHANGES TO ADDRESS NON-HUMAN INSTITUTIONAL DRUG ROOMS

- 65-1626 (jj). "Non-human Institutional Drug Room" means any location where prescription—

 (o) 19 {

 only drugs are stored as part of an accredited school of veterinary medicine and from which

 prescription—only drugs are distributed for (use in treatment of or experimentation on)

 (administration to) a non-human.
- 65-1643 (j). For any person to operate a non-human institutional drug room without first having obtained a registration to do so from the board. Such registration shall be subject to the provisions of K.S.A. 65-1637b and amendments thereto and any regulations adopted pursuant thereto.
- 65-1637b. Non-human institutional drug rooms; supervision and record keeping; rules and regulations. (a) Distribution and control of prescription only drugs in a non-human institutional drug room shall be under the supervision of a pharmacist in charge. The pharmacist in charge shall also be responsible for establishing and maintaining adequate policies and procedures for training of personnel; storage and maintenance of prescription only drugs and equipment; quality assurance, labeling, packaging and distribution of prescription only drugs; record keeping and security.
- (b) The board shall adopt such regulations relating to the policies and procedures for non-human institutional drug rooms as necessary for proper control of prescription only drugs by such non-human institutional drug rooms and adequate safety.
- (c) This section shall be part of and supplemental to the Kansas pharmacy act.

 65-1645(b). (15) non-human institutional drug room, new registration not more than \$40, renewal not more than \$35.

Madan Chair and Members of the Committee:

In July 1998 numerous law revisions were enacted in the Kansas Board of Cosmetology statute. During the past eighteen months several provisions of that law were noted that needed "clean-up" corrections or revisions and two licensure provisions which also needed revising.

Briefly the proposed legislation concerns:

- Fees outlined in the statute but no statutory authority provided:
 - 1. Delinquent school fee;
 - 2. Delinquent instructor fee; and
 - 3. Student instructor permit fee.
- Language which outlines the process for student instructor's to make application for a permit and the manner in which the instructor hours shall be accrued;
- ◆ Language which outlines the state's recognition of "full-time active practice" as a qualification for an individual making an out-of-state licensure application; and,
- ♦ Language which outlines the recognition of another state's disciplinary action against a Kansas licensure applicant or licensee "with certified copy of the record of the action."

The K insas Board of Cosmetology requests that this proposed legislation be scheduled for committee hearing on Thursday, February 3rd.

The Health Care Data Governing Board was created to guide development of the Kansas' Health Care Database at KDHE and to provide a forum for discussion of health information issues. Members of this board include the major health information representatives in the state. Since its inception in 1993, the Governing Board has numerous accomplishments:

The Health Care Database now contains data centralized from 8 licensure boards encompassing 44 health professions.

A total of 140 indicators are being collected and analyzed.


