Brad Bryant, Deputy Assistant Secretary of State, had requested some results from the 2000 elections back to 1990 and some of them on some years would not have produced any automatic recounts under the provision **SB 256** (Attachment 1).

Hearing on: SB 283 - motor vehicles; notice of impoundment required

Senator Huelskamp testified in support of <u>SB 283</u>, stating this bill would provide notification procedures that would notify the owner and lien holder (Attachment 2).

There being no others wishing to testify on **SB 283**, the hearing was closed.

Discussion of bills

SB 218 - relating to provisional ballots

Senator O'Connor made a motion to pass SB 218 favorably, seconded by Senator Clark. The motion carried.

SB 192 - campaign finance; district party committee

On <u>SB 192</u> there was amendment offered on page 3, line 39, after the word "committee" add "per congressional district". <u>Senator Schmidt made a motion to adopt the amendment, seconded by Senator O'Connor. The motion carried.</u>

Senator Schmidt made a motion to move SB 218 favorably as amended. Senator Jackson seconded the motion. The motion carried.

Chairperson Allen requested CarolWilliams to submit to the committee the contributions and expenditures for Congressional Committees.

SB 108 - campaign finance; requirements for electronic filing of reporting campaign contributions

The Governor's office has worked the Ken Wilke, Revisor of the Office of Statutes, and has a balloon for the committee consider.

Ken Wilke, Revisor of the Office of Statutes explained the balloon. This balloon would basically impose requirements of electronically filing that would be necessary if the candidate received \$30,000 in one reporting period, reports dealing with 11 days deals in contribution of aggregate \$100 or more as requested by the governor's office, and other changes noted on balloon (Attachment 3).

Chairperson Allen noted there needed to be a technical amendment on line 42 "July 1, 2002" should read January 10, 2002.

Testimony on Senate Bill 283 before Senate Elections & Local Government Committee by Senator Tim Huelskamp (prepared by Chris Neal) – February 14, 2001

Madam Chairman and members of the committee: It is a pleasure to be here this afternoon to testify on SB 283. I would like to describe first the incident that led to the introduction of this bill.

Early last month I received a phone complaint from a constituent of mine, Ms. Ellie Moore. Ellie is the owner/operator of Moore's Used Cars in Liberal and periodically sells vehicles on credit. I believe it was back in December when she received notice that one of vehicles on which she was a lienholder (a Mercury Sable) had been seized approximately forty-five days prior by the local police department. Authorities had suspected the vehicle's owner was in possession of narcotics.

Due to the dearth of space at the city impound facility at the time, the car was stored at a privately owned (and more expensive) storage facility. And then, the city did not notify Ms. Moore as to the vehicle whereabouts for approximately 45 days. As a result, once the car was available for release, the charges surrounding the incident have surpassed the value of the Mercury Sable.

In examining current statutory law, we could not discover any existing law which pertains to the notification of owners or lienholders as to the seizure of property. In researching this matter my office first contacted the Kansas Bureau of Investigation – we were told to hire an attorney. Then it was on to the Seward County Attorney's Office – we're not sure, call the local police department. And there as well – we do not know. When asked at each turn, no one could provide a definitive answer as to how a situation such as the one just outlined should be handled.

Our research, moreover, has discovered that if such a situation were to have arisen just three miles to the south in the State of Oklahoma, a "courtesy" law exists which dictates that the owner and lienholder must be notified of the impoundment within seven days.

In conclusion, I apologize that Ellie could not make the 350-mile trip here today to testify. We ask that you provide some simple notification procedures for both owners and lienholders when a city or county impounds a vehicle. Madam Chairman, I will be happy to stand for questions on SB 283.
