## MINUTES OF THE SENATE FEDERAL AND STATE AFFAIRS COMMITTEE.

The meeting was called to order by Chairperson Nancey Harrington at 10:30 a.m. on January 30, 2001 in Room 245-N of the Capitol.

Chairman Harrington began the meeting by introducing Senator Chris Steineger, who introduced a bill on slot machines.

Senator Gooch asked if the bill had limited slots only to racing facilities, and Senator Steineger agreed.

Senator Gooch made a motion that the bill be introduced. Senator Barnett seconded that motion. The motion passed.

Chairman Harrington opened hearing on:

### SB 71 Procedures, duties concerning state capitol area and Kansas firefighters' memorial

Chairman Harrington stated that this bill belonged to Senator Adkins, but that, although he had been invited, he had chosen not to submit written testimony and would not appear before the committee.

Mr. Pat Lehman, Kansas Fire Service Alliance, then presented his testimony to the committee. (Attachment 1).

Chairman Harrington drew the committee's attention to the written testimony from Mr. Gale Haag, Kansas State Fire Marshal. (Attachment 2). She also pointed out the fiscal note from the Division of the Budget (Attachment 3).

Chairman Harrington recognized Senator O'Connor who stated that she wanted to know if, because of the wording of the bill, the majority of the funding for the memorial would be private.

Danielle Noe, Assistant Secretary of Administration, then spoke to the committee to explain a written request for a technical amendment to the bill to change the wording from "Director of Architectural Services" to "Director of Facilities Management". (Attachment 4).

Senator made a motion to adopt the amendment. Senator O'Connor seconded. The motion passed.

In response to a question from Senator Gooch, Ms. Noe responded that the maintenance of the memorial would primarily come from private contributions, and that the specific details of the memorial would be approved by a committee with legislative oversight, Capitol grounds management, and ultimately by the governor.

### CONTINUATION SHEET

Senator Gooch then stated that it seemed that this bill did not really accomplish anything because it did not state that there would be an actual memorial. Mr. Lehman stated that the point of the bill was to set up guidelines and criteria to follow in the future.

Chairman Harrington suggested that there might be a balloon amendment to change and clarify that, but then the committee discussed the issue and decided that more clear language could be found in a latter part of the bill.

Senator Vratil moved that **SB** 71 be reported favorable to the full Senate as amended. Senator Teichman seconded the motion. The motion unanimously passed.

Mr. Russell Mills began a staff briefing on the House bill concerning the lottery. He stated that the House bill to extend the lottery for six years, until 2008, had been approved to the House Committee, and that motions for indefinite extension and for one year extension had both failed. Mr. Mills also gave the members a copy of *The Topeka Capital-Journal*, "Lottery Scores Early Win" by Jim McLean, published January 30, 2001.

Senator Vratil asked Mr. Mills to explain the rationale behind six years as opposed to another number, and Mr. Mills replied that the prior extensions had been for six years.

Chairman Harrington then stated that if the House bill passes quickly on the floor, then the Senate Federal and State Affairs committee would simply work the house bill.

Mr. Mills stated that the House Federal and State Affairs committee only six people testified on the lottery bill.

Chairman Harrington then asked for questions, and there were none.

The meeting was adjourned at 11:04 a.m.

The next meeting is scheduled for 10:30 a.m. on January 31, 2001.

### Testimony Before the Senate Federal and State Affairs Committee Senate Bill 71 January 30, 2001

I am Pat Lehman, and I am appearing on behalf of the Kansas Fire Service Alliance to testify in favor of SB 71.

SB 71 requires the Secretary of Administration to develop and maintain a preservation plan and shall develop guidelines and standards for memorials on the Capitol grounds. This bill establishes a mechanism for the State Historic Preservation Officer of the State Historical Society, the Director of Facilities Management, and the Director of Legislative Administrative Services to make recommendations regarding proposals to the Secretary of Administration to place memorials on Capitol grounds.

SB 71 also provides a mechanism to establish an advisory committee of representatives from different fire groups in the state to advise the Director of Architectural Services and the Secretary of Administration with regard to matters concerning a memorial to Kansas firefighters on the State Capitol grounds.

The Kansas Fire Service Alliance supports SB 71 and we urge the committee to pass the bill out favorably.

SUBJECT: Fiscal Note for SB 71 by Senator Adkins

In accordance with KSA 75-3715a, the following fiscal note concerning SB 71 is respectfully submitted to your committee.

SB 71 directs the placement of a memorial to firefighters who lost their lives in the line of duty on property in the Capitol complex. The Fire Marshal would report each year to the Department of Administration the names of firefighters who died. The bill also makes provision for the Department of Administration to develop standards and guidelines for memorials on the Statehouse grounds. Recommendations for future memorials must be approved by the Secretary of Administration, the Capitol Area Plaza Authority, and the Legislature.

The estimated cost of the memorial is unknown because it would be based on the design approved in accordance with the procedures established in the bill. SB 71 makes provision for grants, gifts, contributions, and bequests to finance its construction. Apart from the cost, the ability to finance the memorial would depend on whether sufficient funds can be raised.


