Chairman O'Neal noted there was a quorum of members of the House Redistricting Committee but not of the Senate Committee on Reapportionment as some members were running late. He asked that the members review the materials before them until a quorum of Senators was reached for any joint decisions.

Chairman O'Neal referred the House members to the House Select Committee on Redistricting Rules handout (<u>Attachment 1</u>) while the Senators reviewed the Senate Committee on Reapportionment Rules (<u>Attachment 2</u>). Committee questions and discussion followed. It was noted that the informal public hearings to be held in the summer of 2001 would not be bound by these rules. <u>Representative Mason moved the adoption of the House Select Committee on Redistricting Rules.</u> <u>Representative Howell seconded.</u> <u>Motion passed.</u>

In response to a question from Rep. Wilson, Mary Galligan informed the Committees that Research staff would make arrangements to work with members of the public who wish to draw proposed plans, but that copies of the redistricting software could not be distributed to the public. She also emphasized that members of the public who desire to use the Legislature's system would be assisted by staff and would not be allowed unsupervised access to the system. Ms. Galligan informed the Committees that the first priority for Research staff is responding to legislative requests, including requests from caucus staff. Rep. Wilson followed up by asking whether members of the public could contact a legislator for assistance with developing proposed plans, then the legislator could request assistance from the Research staff. Ms. Galligan said that could be done.

Representative Howell seconded the motion. Motion passed.

Chairman O'Neal requested that staff redraft the guidelines with the House adopted changes so the Senate Committee on Reapportionment could consider the Guidelines. Chairman Adkins indicated he would consider having the Senate Committee on Reapportionment meet at the rail for adoption of the Guidelines.

In addition, electronic submissions must be accompanied by a report that includes an enumeration of the total population of each district, the absolute and relative deviation from the ideal population of each district (expressed as a percentage), the overall deviation of the plan (computed from the largest and smallest districts), the number and percentage of persons of each of the five single race categories, of the number of persons of two or more races and of persons of Hispanic origin (all races) in each district and the number and percentage of voting age population for those same racial and ethnic groups.
- e. Plans or portions of plans that are not submitted electronically, must conform with the following requirements:
 - i. Hard-copy plans must be submitted at least 10 business days prior to presentation to the Committee.
 - ii. All plans, including portions of plans previously submitted, must be on clearly depicted maps that follow U.S. Census geographic boundaries and accompanied by a statistical report listing the census geography in each district. The statistical report must include a list of each unit of geography included in each district. The report must include enumeration of the total population of each district, the absolute and relative deviation from the ideal population of each district (expressed as a percentage), the

In accordance with Kansas law, congressional districts must be based upon the 2000 decennial census from the actual enumeration conducted by the United States Bureau of the Census. Kansas State House, Senate and Board of Education districts must be based upon the 2000 decennial census as recalculated by the Secretary of State in accordance with the Kansas Constitution. Recalculated population data prepared for legislative redistricting can be obtained from the Secretary of State.
- ii. The entire state must be included in the plan.
- iii. All districts must be composed of contiguous geography. For purposes of determining contiguity, water bodies will be treated as if they were land.
- iv. Plans for the state Senate must contain 40 single-member districts. Plans for the House of Representatives must contain 125 single-member districts. Plans for the United States House of Representatives must contain 4 districts. Plans for the State Board of Education (SBOE) must be built on Senate Districts enacted during the 2002 Session with four contiguous Senate districts comprising each SBOE district.
- v. State Senate, House, or Board of Education districts must not exceed an

- overall range of deviation from the ideal district size of 10 percent (expressed as a percentage from the smallest to the largest district) unless accompanied by a detailed explanation of the proponents' understanding of the state's interest in a greater overall deviation.
- vi. Congressional districts must be as nearly equal in population as practicable. In addition, electronic submissions must be accompanied by a report that includes an enumeration of the total population of each district, the absolute and relative deviation from the ideal population of each district (expressed as a percentage), the overall deviation of the plan (computed from the largest and smallest districts), the number and percentage of persons of each of the five single race categories, of the number of persons of two or more races and of persons of Hispanic origin (all races) in each district and the number and percentage of voting age population for those same racial and ethnic groups.
- e. Plans or portions of plans that are not submitted electronically, must conform with the following requirements:
- Hard-copy plans must be submitted at least 10 business days prior to presentation to the Committee.
 - All plans, including portions of plans previously submitted, must be on clearly depicted maps that follow U.S. Census geographic boundaries and accompanied by a statistical report listing the census geography in each district. The statistical report must include a list of each unit of geography included in each district. The report must include enumeration of the total population of each district, the absolute and relative deviation from the ideal population of each district (expressed as a percentage), the overall deviation of the plan (computed from the largest and smallest districts), the number and percentage of persons of each of the five single race categories, of the number of persons of two or more races and of persons of Hispanic origin (all races) in each district and the number and percentage of voting age population for those same racial and ethnic groups.

ii.

- 5. **Staff Review of Plans.** Any plan submitted to the committee must be a complete statewide plan so that the proposal can be evaluated for technical compliance with committee guidelines. All pieces of census geography must be accounted for in some district.
 - a. Non-partisan staff review of any such plan will be to determine whether the plan complies with committee guidelines. The Research Department is not responsible for converting or translating electronic files that do not comply with the format and content requirements contained in these rules. The Research Department is not responsible for notifying the submitting individual or organization of errors or technical problems with a submission prior to notifying the committee of such matters. The Research Department is not responsible for providing technical support to persons or organizations that desire to prepare and submit a plan for consideration by the Committee.

b. Technical Requirements for Plans.

- i. All plans submitted to the Committee must be based on the same population figures and U.S. Census TIGER® 2000 for Redistricting geography used for redistricting by the Kansas Legislature. In accordance with Kansas law, congressional districts must be based upon the 2000 decennial census from the actual enumeration conducted by the United States Bureau of the Census. Kansas State House, Senate and Board of Education districts must be based upon the 2000 decennial census as recalculated by the Secretary of State in accordance with the *Kansas Constitution*. Recalculated population data prepared for legislative redistricting can be obtained from the Secretary of State.
- ii. The entire state must be included in the plan.
- iii. All districts must be composed of contiguous geography. For purposes of determining contiguity, water bodies will be treated as if they were land.
- Plans for the state Senate must contain 40 single-member districts. Plans for the House of Representatives must contain 125 single-member districts. Plans for Kansas congressional districts must contain 4 districts. Plans for the State Board of Education (SBOE) must be built on Senate Districts enacted during the 2002 Session with four contiguous Senate districts comprising each SBOE district.
- v. State Senate, House, or Board of Education districts must not exceed an overall range of deviation from the ideal district size of 10 percent (expressed as a percentage from the smallest to the largest district) unless accompanied by a detailed explanation of the proponents' understanding of the state's interest in a greater overall deviation.
- vi. Congressional districts must be as nearly equal in population as practicable. If plans contain districts that deviate from ideal population, the plan must be accompanied by a detailed explanation of the proponents' understanding of the state's interest that would be furthered by the deviation from ideal district size.

6. ROLE OF THE KANSAS LEGISLATIVE RESEARCH DEPARTMENT

- a. Research Department staff will be available to all members of the Legislature requesting assistance. Census data and hard copy redistricting work maps will be available to all members of the Legislature upon request.
- b. Redistricting plans and other records related to the provision of staff services to individual members of the Legislature will not be subject to public disclosure. This confidentiality provision does not apply to records related to the provision of staff services to any committee or subcommittee when the record is identified in an open meeting or in an agenda of an open meeting or when the record is distributed to a majority of a quorum of a legislative committee or subcommittee. (K.S.A. 45-221(a)(22))
- c. Research Department staff will be available to respond to requests for information from the public as time is available. Research Department staff has as its primary responsibility responding to requests from legislators and committees of the Legislature.

1.	The basis for legislative redistricting is the 2000 U.S. Decennial Census as recalculated by the Kansas Secretary of State pursuant to Article 10, Section 1 of the Constitution of the State of Kansas and KSA 11-301 et seq.
2.	Districts should be numerically as equal in population as practical within the limitations of Census geography and application of guidelines set out below. Deviations should not exceed plus or minus 5 percent of the ideal population of for each House district and for each Senate district, except in unusual circumstances. (The range of deviation for House districts could be plus or minus persons, for districts that could range in population from to The overall deviation for House districts could be persons. The range of deviation for Senate districts could be plus or minus persons, for districts that could range in population from to The overall deviation for Senate districts could be persons.)
3.	The "building blocks" to be used for drawing district boundaries shall be voting districts (VTDs) as described on official 2000 Redistricting U.S. Census maps.
4.	Districts should be as compact as possible and contiguous.
5.	The integrity and priority of existing political subdivisions should be preserved to the extent possible within the constraints of guideline #2.
6.	There should be recognition of similarities of interest. Social, cultural, racial, ethnic, and economic interests common to the population of the area, which are probably subjects of legislative action (generally termed "communities of interest") should be considered. While some communities of interest lend themselves more readily than others to being ambedied in logislative.

- communities of interest lend themselves more readily than others to being embodied in legislative districts, the Committee will attempt to accommodate interests articulated by residents.
- 7. Redistricting plans will have neither the purpose nor the effect of diluting minority voting strength.
- 8. Contests between incumbent members of the Legislature or the State Board of Education will be avoided whenever possible.
- 9. Districts should be easily identifiable and understandable by voters.

ngressional Redistricting

- The basis for congressional redistricting is the 2000 U.S. Decennial Census as published by the U.S. Department of Commerce, Bureau of the Census. The "building blocks" to be used for drawing district boundaries shall be Kansas counties and voting districts (VTDs) as their population is reported in the 2000 U.S. Decennial Census.
- 2. Districts are to be as nearly equal to 672,105 population as practicable.
- 3. Districts should attempt to recognize "community of interests" when that can be done in compliance with the requirement of guideline #2.
 - a. If possible, preserving the core of the existing districts should be undertaken when considering the "community of interests" in establishing districts.
 - b. Whole counties should be in the same congressional district to the extent possible while achieving population equality among districts. County lines are meaningful in Kansas and Kansas counties have historically been significant political units. Many officials are elected on a countywide basis, and political parties have been organized in county units. Election of the Kansas members of Congress is a political process requiring political organizations which in Kansas are developed in county units. To a considerable degree most counties in Kansas are economic, social, and cultural units, or parts of a larger socio-economic unit. These interests common to the population of the area, generally termed "community of interests" should be considered during the creation of congressional districts.
- Districts should be as compact as possible and contiguous.

The following outline was prepared for discussion by the two Committees.

- 1. Organization of work on Congressional plans
 - KLRD will assist members of the public with technical plan drawing. a. Legislative requests (including requests from caucus staff) receive first priority.
 - b. The Chairs, Vice-chairs, and Ranking Minority Members of the standing committees designated to receive and review plans from legislators and plans submitted by outside entities. This is the same arrangement that was used in the 1991-1992 round of redistricting.
 - Preliminary schedule for review of proposed plans C.
 - Between last hearing on June 13 and July 12-First Joint Committee meeting:
 - (1) June 28 – deadline for submission of paper plans to KLRD for staff review
 - (2)July 5 – deadline for submission of electronic plans to KLRD for staff review (including plans developed on the legislature's
 - (3)July 6 – KLRD inform committee leaders of the number plans and their proponents
 - (4)As soon as plans submitted to the Committee are verified for compliance with technical rules, post on web page
 - Chairs prepare and disseminate information regarding plans (5)submitted for committee consideration

Dear LCC:

As you know, much of the work for redistricting will be done during the 2001 Interim. As chairs of the committees with responsibility for that effort, we have developed an ambitious schedule that includes public hearings, joint committee meetings, deadlines for completion of plans for committee consideration, and days for members to be in Topeka to work on plans with staff. We are requesting Legislative Coordinating Council (LCC) authorization for implementation of our plan as soon as possible because we have scheduled public hearings to begin in mid-May. In addition, we have adopted committee rules that include specific duties for the Research staff. We are providing you with a copy of those rules with this request so that you are fully apprised of the Research Department's role in redistricting. Finally, we encourage you to adopt the security and copy cost policies that have been developed by staff for redistricting.

Elements of our work schedule that require LCC approval follow:

- 1 Appointment of the House Select Committee on Redistricting and the Senate Committee on Reapportionment to meet during the 2001 Interim as a Special Committee for purposes of developing redistricting plans for consideration by the 2002 Legislature.
 - a. This request is consistent with the recommendation made by the Redistricting Advisory Group at the end of the 2000 Interim.
 - b. We anticipate the Special Committee will need six days for full joint committee meetings. We have tentatively scheduled those meetings in July, September, November, and December, but request the flexibility to call full Committee meetings when necessary to facilitate timely completion of the interim work.

2. Authorization for committee hearings outside Topeka.

- a. This request also is an outgrowth of the Redistricting Advisory Group's recommendation last year. The standing committees have been briefed on the role of statewide hearings in the redistricting process and have reviewed the schedule we have established.
- b. The plan includes hearings in ten locations over the course of seven days in May and June. Locations of the hearings are: Lawrence, Johnson County, Hutchinson, Wichita, Leavenworth, Kansas City, Manhattan, Independence, Hays, and Garden City. We have attempted to arrange these hearings in a way that will minimize travel and associated costs within the confines of other demands on members' time.
- c. Our request is for 9-13 committee members to attend each hearing, This size hearing panel would include two members from each party in each chamber and a chairman. In addition, we would like the vice chairmen and ranking minority members of the standing committees to have the option of attending any hearing they wish. We have attempted to assign members to hearings in a way that each hearing panel is balanced by geography as well as by party. However, if the LCC wishes to authorize the entire Special Committee to attend each of the hearings, we can make that change in our plan.
- d. Since redistricting is a vital concern to all people of the state, we request LCC authorization for all members of the Legislature, including members of the Special Committee to be paid for attending one of the statewide hearings. For Committee members, that means the possibility of attending one hearing to which the member is not "assigned" to be part of the hearing panel. For noncommittee members, that authorization would make attendance at a hearing more feasible.

3. Authorization for Committee members to be paid for ten work days each in Topeka.

Access to the caucus and Research staff who are assigned to redistricting and to the redistricting computer system are vital to the Committee's ability to complete its work during the interim. It is not feasible to schedule all of that work on days when the full joint committee is in Topeka because the number of staff and computers is limited. So, in order to complete the Committee's work in a timely fashion, we request authorization for Committee members to be paid for ten work days each over the course of the interim. These work days will be in addition to joint committee meeting days and

the statewide hearing days. We have factored into our request the likelihood that members will be in Topeka for other interim work and will be able to schedule time with redistricting staff on those trips. In addition, staff will work on requests for draft plans when members are not in town. Those draft plans can be mailed to members for review between trips to Topeka.

By giving members the flexibility to come to Topeka for redistricting work when their schedules permit and when they can work with staff without other distractions, the detail work of developing and analyzing proposed district plans should go more smoothly than it would otherwise.

In summary, we request:

- Appointment of the two standing committees as a special committee charged with developing proposed redistricting plans for prefiling and consideration by the 2002 Legislature.
- 2. Approval of six joint committee meeting days to be scheduled by the chairman of the Special Committee.
- Approval of seven meeting days outside Topeka. We ask that you specify whether those hearings should be attended by all members of the Special Committee or by hearing subcommittees of 9 to 13 members each. Those hearings will be held in ten locations across the state.
- 4. Approval for each member of the Legislature to be paid for attendance at one of the statewide hearings. For members of the Special Committee, this would be in addition to hearings to which they are assigned as part of a hearing panel.
- Approval of ten paid individual working days for each Special Committee member to use at the member's discretion during the interim for work with staff on redistricting plans.

Thank you for your consideration of this request. We hope that you will see fit to appoint the Special Committee and authorize the days necessary for the Committee to complete its task during the interim and for other members of the Legislature to participate in the hearing process.

Also related to redistricting, we have been advised by staff that two proposed policies have been forwarded to you for consideration and adoption. We encourage you to take appropriate action so that all of the necessary components are in place to begin drawing new plans very soon. Those other matters are:

1. Adoption of computer security policy.

At the end of the 2000 Interim, the Redistricting Advisory Group directed staff to develop a proposed security policy for the redistricting computer system. The LCC followed up on that recommendation at a subsequent meeting by instructing the Research Department to submit the proposed security policy directly to the LCC.

Staff has circulated the proposed policy widely and has incorporated important modifications suggested by the Legislature's technical staff. We encourage you to adopt this policy so that staff can continue this effort by developing and implementing the necessary procedures to ensure the confidentiality of redistricting plans and the integrity of the redistricting database.

2. Adoption of redistricting map, report, and data copy costs policy.

Research staff has developed a proposed policy regarding provision of redistricting maps, reports, and data to the public. This policy may be necessary because the existing LCC policy regarding provision of copies of legislative documents only addresses committee minutes. We encourage you to give prompt attention to this proposed policy.
