The Chair opened the hearing on:

<u>HB 2727 - concerning improvement districts; relating to the powers and duties of the governing bodies thereof</u>

Rep. Don Myers testified that he has sponsored this statute change to allow Improvement Districts organized under the subject statute and are within five mile distance from an incorporated city to have the ability to adopt resolutions to prevent, abate and remove nuisances on private property within the Improvement District. The Representative went on to say, "the Oaklawn Improvement District has sent many letters to other Improvement Districts in Kansas to solicit their approval". He provided the committee with copies of those returned letters from 12 district that were in support of the proposed change. (Attachment #1)

Glen Wiltse, Director of Sedgwick County Code Enforcement, offered Sedgwick County's support to Rep. Myers on **HB 2727.** He explained the procedure that has to be taken to enforce the county codes. If an attempt is not made to comply then citations are written. Once the citation is written it begins the court process. Mr. Wiltse stated that this ties up not only time but cost money as well. He emphasized that they currently have cases that have been in court over 3 years and the property owners are still not in compliance. (Attachment #2)

Mike Taylor, representing the City of Wichita, gave testimony in support of **HB 2727.** He pointed out that this bill is designed to help the citizens of Oaklawn, an improvement district located on the southern edge of the City of Wichita. The residents of Oaklawn Improvement District are taking a renewed interest in their community. They want to make it a better place for themselves and their families to live. Mr. Taylor went on to say, that giving the improvement district the power to abate nuisances and charge the cost of the cleanup work to the property owners, will give the governing board of the improvement district a needed tool to deal with absentee property owners and others who don't keep their lawns mowed, their houses and businesses in shape or allow junk cars and other debris to litter the area. (Attachment #3)

Tom Powell, attorney with Hinkle Elkouri Law Firm LLC, representing Oaklawn Improvement District for the purposes of testifying in favor of **HB 2727**, explained that Oaklawn is governed by a 3 member board that is elected by the electors of the community. This board and community are dedicated to improving the quality of life in Oaklawn. With the removal of the 5-mile limit from the Improvement

District Act they will add another tool that can be used to improve this quality of life for their community. (Attachment #4)

Andree Simonsen Sisco, Secretary and 18 year resident of the Oaklawn Improvement District offered testimony in favor of HB 2727. She indicated that the community is moving forward with many projects to clean up the area so they have a safer, cleaner and more productive place to live. She informed the committee that Oaklawn Improvement District started in the early 50's as a sewer improvement district. A 260 - acre tract southeast of Wichita. The 2000 census showed population of 3,135 with housing units of 1,179. 1,056 are occupied, and of those 549 were renter homes. "When renters move they leave unwanted items behind." She continued to say that some property owners live out of state and are unaware that the renters have even left, let alone the mess left on the street for up to months at a time. This is both sanitary and a safety hazard for the children. She emphasized that community volunteer cleanups have been on going each year, at the expense of the volunteers, since 1996. "It would be easier if we could clean properties as we go and charge it back to the property owners. This way the property owners will stop abusing the clean up system." She made reference to the letters from residents, businesses and other important people that live within Oaklawn Improvement District boundaries that she had brought for the committee to read. (Attachment # 5)

The proponents responded to questions asked by the committee.

There were no opponents to HB 2727.

The Chair closed the hearing on HB 2727.

The hearing opened on:

HB 2337 - an act creating the Kansas advisory council on intergovernmental relations; prescribing the powers and duties thereof

Randy Allen, Exe. Director; Kansas Association of Counties, strongly supports HB 2337, (re)instituting the Kansas Advisory Council on Intergovernmental Relations (KACIR). He stated that specifically, there needs to be a continuous process of studying services provided by all levels of government; the possibility of improving the organizational structure and operational efficiency; and the revenue requirements of the State and all units of local government. (Attachment #6)

Dr. H. Edward Flentje, Hugo Wall School of Urban & Public Affairs of Wichita University, testified on HB 2337. He stated that he is a longtime student of state-local relations and familiar with the work of advisory bodies in other states and nationally, as well as of the Kansas council created in 1969 and abolished in 1975. He believes an official forum for on-going study and recommendations on intergovernmental relations in Kansas makes sense and recommend the committee to pass the bill forward. He did suggest amendments that he felt would increase likelihood of success. (Attachment #7)

Don Moler, League of Kansas Municipalities, appeared before the committee in support of HB 2337. He testified that the League of Kansas Municipalities and Kansas Association of Counties believes that this bill represents a step in the direction of better intergovernmental relations and the improvement of policy making where they would have linkages between state and local government. The council would identify and study issues of interest and importance to local government in Kansas as well as the State of Kansas and help identify policy initiatives and directions which would allow for a closer communication and work within and between the governments of Kansas. (Attachment #8)

Questions were answered by various conferees that were asked by committee members.

The Chair pointed out that there was written only testimony from Mark Tallman, Kansas Association of School Boards, in support of HB 2337. (Attachment #9) And written only testimony from Ashley Sherard, Government Relations Manager, expressing Johnson County Commission's support for reestablishing the Kansas Advisory Council. (Attachment #10)

If an attempt is not made to comply then citations are written. Once the citation is written it begins the court process. We currently have cases that have been in court over 3 years and are not in compliance. A court case is very time consuming.

Oaklawn Improvement District needs the authority to operate under its own abatement authority.

We are requesting that you support Representative Myers and approve House Bill 2727.

HB 2727 is a bill that amends the Improvement District Act. I am here to testify in favor of HB 2727 because: As a long time resident of Oaklawn Improvement District of more than 18 years, I have seen our community come together. We are moving forward with many project to clean up our area so that we have a safer, clean and more productive community.

By you passing **HB 2727** we as an Improvement District will be able to continue with making it a cleaner place to live. Oaklawn Improvement District started in the early 50's as a sewer improvement district. A 260 - acre tract southeast of Wichita, Kansas. The census data for 2000 showed population of 3,135 with housing units being 1,179. Of the 1,179 houses 1,056 were occupied, of those 549 were renter homes. When renters move out they leave their unwanted items behind. Some owners of the property live out of state and are unaware that the renters have left behind a mess leaving these items on the street side for up to months at a time. This is both unclean and a safety hazard for our children.

Oaklawn Improvement District along with Sedgwick County and many community volunteers held a clean up in 1996 where we went in and cleaned up more than 116 properties. In 1997, 1998 and 1999 clean ups were held. In 2000 we held another large clean up with the Oakview Neighborhood Association, Sedgwick County, Sedgwick County Community Policing and a number of volunteers that started off to be a weekend project that ended up taking up two weeks to complete. Chairperson Ray and members of the committee, my name is Randy Allen, Executive Director of the Kansas Association of Counties. I am here today to strongly support HB 2337, (re)instituting the Kansas Advisory Council on Intergovernmental Relations (KACIR).

I have served in the position of KAC Executive Director since April, 1996. During this time, I have increasingly perceived a need to personally work harder to bring counties, other units of local governments, and the State of Kansas into a closer, more constructive working relationship. In the press of legislative business here in the Capitol, and in the press of daily decisions made at county courthouses across the State, there is a significant need for an ongoing forum and process to thoughtfully and seriously study intergovernmental relations. Specifically, there needs to be a continuous process of studying services provided by all levels of government; the possibility of improving the organizational structure and operational efficiency; and the revenue requirements of the State and all units of local government.

The transition in leadership at the State and local levels seems to be accelerating. No one wants to serve as an elected official for very long, it seems, as there is an unavoidable punishment from the electorate and a huge personal toll. The result of more frequent transitions in leadership is that institutional memory is more difficult to sustain. The **context** of policy decisions -- even when perfectly clear at the time policy is made -- often blurs over time as successors interpret and reinterpret the intentions of their predecessors.

For these reasons, we suggest that one of the most practical and farreaching decisions of the 2002 Kansas Legislature would be to establish the
Kansas Advisory Council on Intergovernmental Relations. We were part of the
process in drafting HB 2337, which envisions a KACIR comprised of 15 members. While we stand behind our bill, we are not so attached to every significant
detail that we will not welcome suggestions to make the KACIR even stronger
and more effective. We thank the Chairperson and committee for considering this
legislation, and hope to move it through the legislative process to enactment.
I will be happy to answer any questions you have.

Testimony on House Bill 2337 by H. Edward Flentje Presented to the House Committee on Local Government February 12, 2002

Thank you for the opportunity to testify today on H.B. 2337, a bill that would establish the Kansas Advisory Council on Intergovernmental Relations. I am a student of state-local relations and generally familiar with the work of such advisory bodies in other states and nationally, as well as of the Kansas council created in 1969 and abolished in 1975. As a former state official I have followed consideration of legislative proposals such as the one under consideration here today.

I believe an official forum for on-going study and recommendations on intergovernmental relations in Kansas makes sense and recommend the committee pass H.B. 2337 forward. Hundreds of pages of state statutes determine the nature of state-local relations in our state, millions of dollars pass between and among state agencies and local governments each year, and most state agencies and a few thousand local governments are engaged daily in such interaction. Yet, no state official, no executive or legislative office, basically no one, has been assigned authority for examining these complex relationships on an on-going basis and making recommendations for improving relations of state and local governments.

I do suggest amendments that would in my opinion increase the likelihood of success for the Kansas advisory council envisioned in H.B. 2337:

O limerate town ships School duit. This limit their Scope

First, focus the advisory council on relationships between and among state authorities, cities, and counties. In other words, add language expressing this focus to section 2 and eliminate township and school district appointments to the council in section 1. Ninety-nine percent of intergovernmental relations among general-purpose governments is conducted by cities, counties, and state officials. Help the advisory council succeed by limiting the scope of its assignment.

Second, assign the governor responsibility for designating the chair of the advisory council (see section 1d). This assignment will align the council as an executive agency, enhance continuity, and create more potential for gubernatorial initiative and leadership with respect to the work of the council.

Third, encourage the League of Kansas Municipalities and the Kansas Association of Counties to suggest gubernatorial appointees to the council but do not limit the governor's authority to make appointments to the council (ie., strike lines 25 and 26, in section 1).

Fourth, figure out a source of modest but stable financing for the advisory council.


First I would like to thank the Committee for allowing the League to appear here today in support of HB 2337. We believe HB 2337 represents a step in the direction of better intergovernmental relations and the improvement of policy making where we have linkages between state and local government. HB 2337 would create the Kansas Advisory Council on Intergovernmental Relations (KACIR). While the KACIR is not a panacea for fixing everything that needs to be fixed, it takes us a good way down the road towards closer communication between state and local governments. Certainly I would think we would all agree that in these uncertain times, it cannot hurt to allow for greater interaction between state and local government.

As envisioned by the League, those individuals comprising the KACIR would serve without pay and would participate because of their interest in the issues which face local government in Kansas. We feel this is a very low risk approach to allowing greater interaction and communication between and among cities, counties and the state, as well as other entities of local government, and would provide the ability to focus on specific issues, alternatives, and approaches for solving various problems which now face government in Kansas.

The League would urge this Committee to favorably report to HB 2337 as a step in the direction of good public policy and good government in Kansas. We believe it can do no harm and can only provide one more tool in the tool box of better government and services to the public. Thank you for allowing the League to testify today. I would like to express the Johnson County Commission's support for reestablishing the Kansas Advisory Council on Intergovernmental Relations (KACIR), as a means to strengthen relationships between government at all levels and to promote more coordinated and efficient delivery of services to Kansas taxpayers.

Government continually strives to become more streamlined and efficient in serving the public, particularly during difficult economic times. Critical to this effort is an understanding of the needs and responsibilities of each level of government in order to avoid redundancies, minimize taxation, and ensure coordinated delivery of services.

KACIR was originally established in 1969 as a neutral body to study the services provided by various levels of government, the relationship between state and local governments, state and local tax structures, and the revenue requirements and fiscal policies of the state and its local units. KACIR was abolished by the legislature in 1975, however, as part of a movement to streamline the executive branch.

The nation is currently in a time of economic uncertainty, and virtually all units of government are experiencing significant revenue shortfalls that are unlikely to be resolved in the short-term. Reinstitution of the KACIR would help to ensure that Kansas citizens are receiving and continue to receive the most value from government for their tax support.

For these reasons, the Johnson County Commission supports HB 2337 and urges the committee to recommend the bill favorable for passage. Thank you for your time and consideration.
