The meeting was called to order by Chairperson Senator Karin Brownlee at 8:30 a.m. on March 26, 2002 in Room 123-S of the Capitol.

SB 649-An act concerning tax increment financing; relating to major tourism areas.

April, Holman, Legislative Research briefed the committee on <u>SB 649</u> stating it would allow for the extension of limited tax increment financing to an area in Wyandotte County that is contiguous to the current NASCAR redevelopment area. The tax increment financing would be limited to arts, entertainment or recreation facilities. Some of the provisions in the bill are capital improvements costing at least \$50M in the state and would create at least 500 permanent and seasonal employment positions.

Senator Steineger, District 6, testified in support of <u>SB 649</u> and presented some balloon amendments. The balloon amendments cover the following three proposed sites: Zone A, adjacent to the NASCAR development area; Zone B, Indian Springs Mall; and Zone C, far eastern Wyandotte County consisting of about 10 acres. The intent of the bill is that property taxes cannot be abated or used to pay off the bonds. The balloon amendment also addresses that STAR bonds could not be used to finance casinos, gambling industries and casino hotels.

Senator Barone asked absent this legislation does the county have the authority to grant tax abatement on this property for development? Senator Steineger stated they have the authority to do Tax Increment Financing which involves property taxes.

Chairperson Brownlee referred to Page 9 of <u>SB 649</u> and commented the bill states the project shall not receive any property tax abatement and does that mean the unified government cannot TIF the area. Senator Steineger stated that is correct. On the original 400 acres that has Cabellas and the Nebraska Furniture Mart it was drafted into legislation they could not use property tax revenue to pay off the bonds. The idea is that property tax would go to the city, county, school district and the state-wide mill levy would be collected from day one which is the same intent for Zones A, B and C.

Rick Worner, Fahnestock & Company, an investment banking firm out of Kansas City, testified in support of <u>SB 649</u> stating his company was fortunate in bringing Cabellas and the Nebraska Furniture Mart to Kansas and that STAR Bond legislation was a big drawing point. STAR Bond legislation is the most powerful economic development tool for the State of Kansas.

There being no further conferees wishing to testify on SB 649, the hearing was closed.

Chairperson Brownlee stated to committee members that they would work <u>SB 649</u> tomorrow and then asked Senator Steineger if he would consider limiting the bill to Zone A.

SB 614-Funding KAN-ED with KUSF.

Hal Gardner, Coordinator, Educational Technology, Kansas State Department of Education, testified in support of <u>SB 614 (Attachment 1</u>). Some of the derived benefits from KAN-ED for teachers and students in the Kansas School districts will be teaming, collaboration, scientific modeling and course delivery.

There being no further conferees wishing to testify on **SB** 649, the hearing was closed.

Committee members were provided a copy of the Senate Substitute for <u>SB 614</u> that amends one section of statute 66-2010. This section would authorize KAN-ED funding which would go through the appropriation process. The Executive Director of the State Board of Regents would certify to the KUSF administrator the amount provided by the Legislature through the appropriations process. The percentage that is collected from phone bills for KUSF support is effective each year on March 1. If this is approved, the first submitted budget would cover the second half of the 2003 fiscal year and would cover the entire 2004 fiscal year for the amount submitted to the KUSF administrator.

Senator Jordan moved, seconded by Senator Emler to adopt the substitute bill for SB 614. Motion carried.

Senator Emler moved, seconded by Senator Jordan to move the substitute for **SB** 614 out favorable for passage. Motion carried.

Janet Buchanan, KCC, presented Committee members with data regarding Broadband Deployment and Competition (<u>Attachment 2</u>). Ms. Buchanan also provided additional information per a request from the committee regarding rates in rural areas of the state during the hearing on <u>HB 2754</u> (<u>Attachment 3</u>).

Meeting adjourned at 9:30 a.m.

Comments before the Senate Commerce Committee related to SB 614, KAN-ED.

Made by Hal Gardner Coordinator, Educational Technology Kansas State Department of Education

For over four years, the KSDE has been working to make KAN-ED happen. It is an equity issue. It is a deployment of resources issue. And, it is a money issue. Economies of scale that can be realized only with the implementation of the KAN-ED model.

KAN-ED is an essential condition for meaningful education in the 21st century – It is not optional. Children in school today will be working in jobs that do not currently exist. How are we preparing them for that 21st century future that is upon us today? Generally speaking, we aren't. Information Literacy skills can only be acquired by students with the technology elements – the foundation – in place. They must be a given. In order for students and teachers in all 304 Kansas districts to benefit from teaming, collaboration, scientific modeling, and even course delivery, there must first be in place a system – both a clearinghouse repository and a delivery capability. In KAN-ED, that begins to happen.

Two weeks ago, a group of us gathered in Kansas City at the Kauffman Foundation to bring about what is now called the *Midwest Partnership for Digital Development*. This group made up of Public Broadcasters from Illinois, Missouri, and Kansas along with State Education departments and many others - is setting about the task of digitizing their many media-rich resources. This won't be an isolated instance of such development.

Initiatives funded federally under what is known as Star Schools, are preparing to digitize their resources widely known for their effectiveness in classrooms all over America. Science, math, language arts and the fine arts along with a multitude of media-rich resources in the social studies have been developed over the years with a limited reception because of technological inequities among schools and school districts. KAN-ED closes the gap. Digital archiving and delivery is economical.

It will be the means by which all media well eventually be amassed and delivered to storage systems such as the hard drive on your computer. Students and teachers will then be able to draw upon the data as primary resources for research, background preparation, investigation, analysis, and ultimately, presentation to others locally, regionally, nationally, and throughout the globe. Distance learning as we now understand it, will be fundamentally changed. Classroom exchange – students and teachers talking with one another across distances will also be able to leverage media-rich material that will be embedded in lesson plans and student work. KAN-ED is the means for deployment not just in Kansas City or Wichita, but throughout the entire state.

KSDE through the annual technology leadership conference and their fall road shows throughout the state have been preparing schools for the advent of KAN-ED. They understand. They know too, that with the inclusion of libraries and hospitals along with the higher education community on the network, the horizons expand even further than we can now know. It is a brilliant future.

My letter dated March 1, 2002 in response to a legislative inquiry about use of Kansas Universal Service Fund ("KUSF") funds received by SWBT, I stated that SWBT does not have an accounting record for dollars received from the KUSF that is separate from the accounting of dollars received from any other source. My conclusion is that no better evidence can be presented that the KUSF system is working as intended and that those funds are being utilized as intended, than the fact that SWBT continues to offer basic telephone service in those exchanges at a reasonable rate five years after establishment of the KUSF.

During the hearing on Substitute for House Bill No. 2754, the Committee requested additional information regarding rates in rural areas of the state. This letter serves as the Commission's response to this request.

Attached is the requested rate comparison. The attachment contains the name of each independent rural telephone company, the exchanges within each rural company's territory, the residential rate (including any charge for Touch Tone dialing), the rate SWBT charges in an exchange of comparable size, and the rate charged by Sprint/United in an exchange of similar size.

Rate increases for SWBT and Sprint/United were recently approved by the Commission in Docket Number01-GIMT-082-GIT. The Commission approved a Stipulation and Agreement in which SWBT and Sprint/United agreed to make access charge reductions. To compensate the companies for revenue lost through the reduction in access charges, SWBT and Sprint/United were permitted to increase local rates. The Stipulation and Agreement states that Sprint/United and SWBT could not increase residential rates in rural areas consisting of less than 1,500 access lines to more than \$17.00 per month and rates in other areas to more than \$21.00 per month. The attachment reflects SWBT's rate increase as a result of this docket. Sprint/United will increase rates in June 2002, June 2003, and June 2004. In June of 2004, the residential rates of Sprint/ United that are referenced in the attachment will be:

Junction City and Milford have a residential rate of \$12.31. (By June 2004, residential rates in these areas will be \$20.00.)
