First I would like to thank the Committee for allowing the League to appear here today in support of HB 2337. This bill was introduced at the request of the League of Kansas Municipalities and the Kansas Association of Counties during the 2001 Legislative Session by this Committee and is an initiative of the League and the KAC. We believe HB 2337 represents a step in the direction of better intergovernmental relations and the improvement of policy making where we have linkages between state and local government. HB 2337 would create the Kansas Advisory Council on Intergovernmental Relations (KACIR). This council would study issues of interest and importance to local government in Kansas as well as the State of Kansas and help to identify policy initiatives and directions which would allow for closer intergovernmental communication and work within and between the governments of Kansas.

It is clear that the reestablishment of the KACIR would provide a forum for allowing the discussion of pertinent topics on a regular and ongoing basis. It could help identify issues that needed to be addressed by the legislature as well as those that need to be addressed at the local level. While the KACIR is not a panacea for fixing everything that needs to be fixed, it takes us a good way down the road towards closer communication between state and local governments. Certainly I would think we would all agree that in these uncertain times, it cannot hurt to allow for greater interaction between state and local government.

As envisioned by the League, those individuals comprising the KACIR would serve without pay and would participate because of their interest in the issues which face local government in Kansas. We feel this is a very low risk approach to allowing greater interaction and communication between and among cities, counties and the state, as well as other entities of local government, and would provide the ability to focus on specific issues, alternatives, and approaches for solving various problems which now face government in Kansas.

The League would urge this Committee to favorably report to HB 2337 as a step in the direction of good public policy and good government in Kansas. We believe it can do no harm and can only provide one more tool in the tool box of better government and services to the public. Thank you for allowing the League to testify today. Chairperson Allen and members of the committee, my name is Randy Allen, Executive Director of the Kansas Association of Counties. I am here today to strongly support HB 2337, (re)instituting the Kansas Advisory Council on Intergovernmental Relations (KACIR).

I have served in the position of KAC Executive Director since April, 1996. During this time, I have increasingly perceived a need to personally work harder to bring counties, other units of local governments, and the State of Kansas into a closer, more constructive working relationship. In the press of legislative business here in the Capitol, and in the press of daily decisions made at county courthouses across the State, there is a significant need for an ongoing forum and process to thoughtfully and seriously study intergovernmental relations. Specifically, there needs to be a continuous process of studying services provided by all levels of government; the possibility of improving the organizational structure and operational efficiency; and the revenue requirements of the State and all units of local government.

The transition in leadership at the State and local levels seems to be accelerating. No one wants to serve as an elected official for very long, it seems, as there is an unavoidable punishment from the electorate and a huge personal toll. The result of more frequent transitions in leadership is that institutional memory is more difficult to sustain. The **context** of policy decisions — even when perfectly clear at the time policy is made — often blurs over time as successors interpret and reinterpret the intentions of their predecessors.

For these reasons, we suggest that one of the most practical and farreaching decisions of the 2002 Kansas Legislature would be to establish the Kansas Advisory Council on Intergovernmental Relations. We were part of the process in drafting HB 2337, which envisions a KACIR comprised of 15 members. While we stand behind our bill, we are not so attached to every significant detail that we will not welcome suggestions to make the KACIR even stronger and more effective. Thank you for considering HB 2337. We urge the committee to report the bill favorably for passage.

The City of Overland Park appreciates the opportunity to offer testimony in support of House Bill 2337, creating the Kansas Advisory Council on Intergovernmental Relations.



Thank you for the opportunity to speak regarding House Bill 2996. On behalf of the Johnson County Election Office, I express support of this Bill.

Elections in Johnson County and throughout the State of Kansas changed dramatically in 1996, with the implementation of provisional balloting. Prior to 1996, this was referred to as challenged balloting. As an example, in Johnson County the total number of challenged ballots in 1988 and 1992 were 106 and 141 respectively. In the 1996 and 2000 Presidential elections, the number of provisional/challenged ballots grew significantly, numbering over 5,000 in both elections.

Additional time is necessary in order to adequately research the voter's eligibility on each of the provisional ballots. For example, a large quantity of our provisional ballots is a result of voters moving within the county. State law allows the voter to go to their new voting location, complete a voter registration application, and vote a provisional ballot. These ballots are sealed in a security envelope and returned to the Election Office for research prior to presenting to the Board of County Canvassers on Friday morning.

On each provisional ballot, the Election Office staff must first verify that the voter is an eligible, registered voter; next they must check the registration list from the voter's old precinct to confirm that they did not vote at that location; then they must confirm that the voter voted the correct ballot at their new voting location.

In a close race, the provisional ballots can determine the outcome of an election. The significance of the provisional ballot was reaffirmed in Johnson County in the spring 2001-city/school elections. On Election night, the Mayor's race in one of our cities was within one vote, with eight provisional ballots collected in that race. The county Canvass Board authorized seven of those provisional ballots to be counted. The winner of the race on Election night became the loser by two votes after the provisional ballots were counted.

There is a critical need for more time to process provisional ballots, especially in the two large counties. House Bill 2996 gives the county election officer the ability to move the official canvass date to the Monday following the election. For this reason, I express support of House Bill 2996.

The election of 2000 has brought realization to many people that perhaps there are changes that should be made in the administration of elections. One of the changes recommended by the Ford/Carter Commission on Election Reform, as well as other task forces and election administrators, is to provide more time for election officials to review election returns before having to present them for final canvass.

In November of 2000 the Sedgwick County election office had more than 2,000 provisional ballots taken at the polls on Election Day. Provisional ballots are provided at each voting place for voters who have moved and/or changed their name and failed to reregister prior to the deadline, for voters about whom there is a question concerning their registration, and voters who may be challenged. Providing provisional ballots is an important focus of pending federal legislation.

The steps required to process each ballot are many and complicated. Each voter's registration information must be checked with office records to verify that all provisions of the law have been met. If the voter moved, because he is required to vote in his new precinct where his name is not on the registration book, the registration book of his former precinct must also be checked to ensure that he did not vote at that precinct as well. Then ballots must be organized into categories for easier presentation to the Board of Canvassers. And guess what! There are frequently dozens of different categories represented.

Because of the importance and complexity of checking the provisional ballots, most phases of the job cannot be given to seasonal personnel. It takes the experience of full time staff to guarantee the accuracy of the information gathered. And because the full time staff has been working long hours of overtime for several weeks prior to the election, efficiency is low.

Senate Elec + Loc Gov 03-19-02 Attachment 8 In addition to the provisional ballots, write-in votes must be tallied and verified manually in most Kansas counties. All supplies from the polls must be checked to make sure that all necessary items are in hand and signed if they need to be.

Not every election canvass will need to be changed to Monday. And not many counties will ever need to change the day from Friday. But for those few of us who need extra time – probably only in November – it gives us the flexibility to ensure that all figures released for certification are indeed "true and correct".

Thank you for allowing me the opportunity to speak to you about HB 2996. Each year our Elections Committee meets and decides which statutes could be changed to streamline the election process as well as insure the integrity of the election process. Integrity is always foremost in our minds.

Each year the Committee picks a priority item and then we give it our full support. In the past we have supported 16 & 17 year olds to be allowed to be poll workers, the last 4 numbers of the social security number required on the registration form, etc.

This year the Committee had quite a discussion about the Canvass of Votes on Friday after the Tuesday election. As the laws are loosened more and more to allow people to vote we have more and more provisional ballots. For instance the law that allows registered voters to move within the county and not having to reregister before coming to the polls. This is the biggest bulk of our provisional ballots. Having the Canvass of Votes on Friday does not give us enough time to throughly check out the voter information. Kansas Elections are considered above reproach and we want to keep it that way. For this reason, we ask for your support of HB 2996.
