House Bill 2905

Madam Chair and members of the Committee, thank you for the opportunity to testify in support of House Bill 2905. HB 2905 proposes to create a commission on health to oversee and make recommendations on all aspects of health in Kansas. The commission will focus primarily on prevention, health promotion and the reduction of health disparities throughout Kansas.

HB 2905 provides Kansas the opportunity to develop health policy in a comprehensive way by requiring participation on the commission of a broad array of professionals including policy makers, health care providers, insurers, educators, consumers and state agency representatives, among others.
