Judicial Council Bill Requests

The Kansas Judicial Council respectfully requests two bills be introduced by the House Corrections and Juvenile Justice Committee this year. They are:

- The proposed recodification of the Kansas Juvenile Justice Code. The Judicial Council has recently completed a two-year study of the Kansas Juvenile Justice Code requested by the Legislature. The study proposes clarification and reorganization of the code and a number of policy changes.
- A bill amending the Child in Need of Care Code regarding the appointment of a guardian ad litem to represent a child when a child's position is not consistent with the guardian ad litem's as to what constitutes the child's best interests. The bill is similar to 2002 SB 399 which passed the Senate last year.
