Bill #1 Hazardous Waste Technical Correction

A correction to a statutory reference in K.S.A. 65-3441 is needed. In paragraph (a) (1), the reference to "65-3431" should be changed to "65-3451". This error was identified by the Joint Committee on Rules and Regulations earlier this year.

Bill #2 Convert "waste oil" to "used oil" in solid waste law and define "used oil"

The proposed change is needed to make the terminology used in state law (waste oil) consistent with the terminology used in federal regulations that have been adopted by reference(used oil). This change will eliminate confusion as whether "used oil" and "waste oil are the same thing, but will not change the applicability of any environmental compliance requirements.

Bill #3 Eliminate the Requirement to Publish Policies and Guidelines

This bill would repeal K.S.A. 75-5662 which requires KDHE to publish an annual update of all of all Division of Environment policies and guidelines. No requests have been made for this publication in the past four years. Most desired documents are published on the department's web pages or can be obtained free of charge or at a very low copying cost.

Bill #4 Environmental Use Control Bill

The original version of this bill was introduced by KDHE last session and was passed by the House, but stopped by the Senate. This bill has been updated from last year based upon industry input. The bill establishes a system for assigning environmental use controls on property deeds where wastes or contamination is allowed to remain. By assigning and enforcing such controls, the public will be adequately protected and some properties may be returned to beneficial uses without expending the money needed for more thorough clean-up.

Bill Introduction Executive Summary

Amending access statutes regarding guide, service, hearing and other assistance dogs

The proposed legislation adds and clarifies definitions of guide, service, hearing and professional therapy dogs. It clarifies distinct differences between assistance dogs serving people who have disabilities as opposed to pets, focusing on tasks dogs must be able to perform to be regarded as guide, service, hearing, or professional therapy dogs. It establishes legal remedies for interference, injury, assault, or intimidation of working teams of disabled persons and their assistance dogs. The legislation also establishes criteria for identification of assistance dog teams. The Bill would further amend existing statutes so that each established category of assistance dog serving a disabled handler receives equal access rights under the law. The bill further defines and clarifies the role of professional therapy dogs, who, with their handlers, work in professional, formal settings to provide therapeutic services, and establishes limited access rights for such dogs.
