The meeting began with the approval of past committee minutes. Senator Emler moved to approve the minutes from February 19, 20, 21, 24, 25, 26, March 5, 6, and 7. Senator Bunten seconded. The motion carried.

Chairperson Brownlee opened the hearing on HB 2208. Mike Taylor, City of Wichita, testified as a proponent to the bill. (Attachment 1) He said that Wichita is doing a lot to develop and attract business, and he welcomes the state partnership. This bill would help Wichita continue to improve its downtown area. The Wichita WaterWalk is an exciting new project that will help create jobs and attract tourists and would benefit from this bill.

Larry Baer, League of Kansas Municipalities, testified in support of HB 2208. (Attachment 2) This legislation would encourage major economic development or redevelopment projects with regional or statewide importance. Starbonds and TIF laws have proven to be very effective vehicles to help attract and grow the economy.

Ed Wolverton, Wichita Downtown Development, testified in support of the bill. (Attachment 3) Starbonds would be a critical tool in Sedgwick County to support business development efforts. Starbonds do not raise taxes, do not create any "out of pocket" costs to the state, and they spur economic activity. Mr. Wolverton brought with him a number of written testimonies in support of the bill:

There were no opponents or neutral parties wishing to testify. Chairperson Brownlee closed the hearing on HB 2208. She announced that the committee will work this bill tomorrow, depending on what the House does with SB 235.

The Wichita City Council wholeheartedly supports House Bill 2208 and enthusiastically endorses the use of STAR Bonds to help us move some major plans for downtown Wichita from the drawing board to reality.

PRESIDENT Edwin J. Wolverton The Wichita Downtown Development Corporation is a non-profit organization focused on stimulating new economic investment and activity. Because of our economic development focus, we are aggressively working to help create new jobs and bring new investment to the region's dominant business center. As a Sales Tax Revenue (STAR) bond area in Sedgwick County would be a critical tool to support business development efforts, we strongly support House Bill 2208 and encourage its passage.

As you know, the STAR bond program is a State initiative that allows local communities to issue bonds that are secured by growth in sales tax revenues from new businesses that locate into an authorized area. Although this is a State-wide program, Wyandotte County is the only community with STAR bond areas.

In examining the results from Wyandotte County, the STAR bond program has been a phenomenal success in generating new jobs and investment. We are hoping to generate similar economic gains by creating a STAR bond area in Sedgwick County.

House Bill 2208 is modeled precisely on existing legislation that created the two STAR Bond areas in Wyandotte County. It proposes an area of about 460 acres, which is well within the size of the current areas. The boundaries also meet all of the existing eligibility requirements as it contains blighted conditions, a conservation district, an environmentally contaminated area and is within a State enterprise zone. By meeting all of the state-mandated criteria, rather than just one, we believe that the proposed boundary makes a strong case for STAR bond eligibility. The proposed area also makes allowances for existing and anticipated land use development patterns.

The bill has two minor revisions to the Wyandotte County legislation. First, HB 2208 creates and defines a new term. As the existing legislation defines a "major tourism area" as an auto race track facility, HB 2208 builds on that foundation to introduce the term "major commercial, entertainment and tourism area." It further specifies a "river walk canal facility". Just as the Wyandotte County bill integrated the trigger project into the legislation, this language in HB 2208 does the same thing.

The second revision focuses on sales tax revenues eligible for STAR bond collections. Specifically, the Wyandotte County bill requires that all sales tax revenues collected within a STAR bond area must go to pay off the STAR bonds. HB 2208 specifies that only sales tax revenues generated by new businesses within a STAR bond area can be captured. This insures that a STAR bond project will maintain the current sales tax revenue stream from existing businesses and allows for the State to capture any growth in sales taxes from existing businesses already within a proposed area.

The bill also contains two additional clarifications. This includes a local provision that requires a public vote on an arena if a facility is proposed within the project area and if the arena proposes to use STAR Bonds. The other clarification requires local government to pledge new sales tax revenues generated by a project within a STAR bond area to pay off the bonds.

In terms of timing, Sedgwick County currently has project that may be eligible for STAR bonds. The Wichita WaterWalk is a mixed use, redevelopment project that would add significant commercial space within a unique and visionary urban environment. The project includes \$100 million in new private sector investment, \$20 million from a developer funded Tax Increment Finance district and \$10 million in public funds for public infrastructure.

The investors are now negotiating with a national, destination retail tenant that would be an anchor tenant for the project. As additional public infrastructure would be needed to support the project, STAR bond eligibility will be a critical element that can bring negotiations to a successful conclusion. While I cannot yet publicly divulge details about the prospect and their economic impact, this is a real prospect that will generate real benefits. Given the current status, I must stress the need for the committee and the Legislature to act during this session on this bill.

In short, we have project that already been publicly approved by the City of Wichita. We also have local, civic minded investors who are following the Wyandotte County model to seek the State's approval of a STAR bond area to help build public infrastructure. Lastly, we have a prospect that is almost ready to commit to the project and supply the necessary data for the Lieutenant Governor to make a STAR bond determination.

HB 2208 offers an opportunity for another community to participate in the STAR Bond program. As STAR bonds do not raise taxes, do not have any "out of pocket" cost to the State and spurs economic activity, my organization supports the measure. While we will continue to advocate the approval of SB 235, we believe that these two bills will have an immediate impact on our community and economy. As inaction will mean the loss of a critical tool that will create new jobs and business investment at a time when our economy desperately needs help, I encourage the committee to approve the bill and champion its approval by your colleagues in the Senate.

Dear Chairperson and members of the committee,

I am writing this testimony in support of House Bill 2208.

The Wichita Chamber's economic development division has been a strong partner in supporting the downtown WaterWalk project. The City of Wichita selected and contracted with an investment group to develop a 25-acre site along the Arkansas River. The investors have announced a development plan that includes office, restaurant, residential and retail components that will require a total private investment of \$100 million. To help pay for pubic improvements, the City created a developer-funded Tax Increment Financing District to support public improvements including a parking garage, street improvements, sidewalks and the waterway, or canal. The City is also using roughly \$10 million in Capital Improvement Funds to improve the riverwalk and other elements within the area.

As is evidenced by this example and many others that have included the State's participation, the return on the investment of public sector dollars is significant. *Public/private projects do work, and they work well.*

Currently, downtown Wichita is about 20 percent of the total tax base for the City of Wichita. Beyond the economic impact of new visitor dollars gained from developing attractions within the proposed Star Bond district, the *overall increase in property values* realized through the addition of office, restaurant, residential and retail components will have *significant impact on our tax base for the city, county and school district*.

But furthermore, it is important to note the appeal that a renewed, vibrant downtown will have to new companies considering Wichita for relocation or expansion. While the supply of labor and cost of doing business will ordinarily be the top drivers for site selection decisions, often quality of life factors become the qualifier at the end of the race. Just as Wyndotte County has been granted your support of Star Bonds to add an appealing quality of life feature to their landscape, we need your support to develop a city that has special appeal to companies and qualified workers in order to keep our economy growing.

While we enthusiastically support legislation that will give communities the opportunity to flourish with this new financing tool, we also insist that our particular project is depended upon swift action of the legislature this session. We urge you to embrace the vision that we have for southcentral Kansas by supporting this project specific bill, HB-2208 just as you did the state-wide legislation that was recently passed by the Senate – SB-235.

On February 20, 2003, our Board took a formal position of support on the STAR Bonds proposal. The passage of this legislation will significantly enhance the economic development efforts of the proposed area and revenues locally and statewide.

Members of the Senate Commerce Committee,

As its president I serve the Delano Neighborhood Association. Additionally, I am a member of the Delano Business Association and the President of the Delano Development Corporation.

I am writing to provide support for HB 2208 to create a STAR Bond eligible area in Wichita. A portion of the Delano area is within the created STAR Bond area.

The Delano Neighborhood Association represents about 10,000 residents and is focused on economic and community development projects to make the area a better place to live. The Business Association has about 100 members and is dedicated to creating a business environment for commercial property owners and significant work with our Metropolitan Area Planning Commission.

After years of work, the Mayor and City Council adopted the Delano Neighborhood Revitalization Plan. Major elements of the plan included:

- An urban village with mixed uses
- Continued expansion of the museum district
- Programs to stimulate home ownership
- Programs to stimulate building renovation and improvement projects
- Streetscape improvements
- Zoning and land use changes

A STAR bond area that includes a portion of the Delano Neighborhood will support the Cityadopted plan and accelerate our redevelopment efforts. The legislation would be an especially critical tool for the urban village project, which is the northwestern corner of the proposed boundary.

The proposed boundary reaches into the museum district, which meets the tourism criteria within the existing legislation. The City and community have implemented many projects in this area and spent millions of dollars to define a museum district. Recent projects include realigning McLean Boulevard and building Exploration Place.

As the Aviation Museum and the African American Museum are both currently looking for locations in Delano and the museum district, the proposed STAR bond area could be critical in helping to develop these regional and state institutions.

The City has also just approved a streetscape improvement plan within the STAR Bond area. Due to higher than anticipated cost estimates, the City had to cut back on some elements of the streetscape plan. A STAR bond area, along with an approved project, could provide a new funding source that would allow the City to put these elements back into the improvement projects.

On behalf of the city of Olathe, thank you for the opportunity to add support for HB 2208. This bill would allow the use of STAR bonds for a new category of "major commercial, entertainment and tourism" project of statewide importance located in Sedgwick County. As the committee knows, the city of Olathe supports broadening the use of STAR bonds for projects worthy of statewide significance without respect to geography. This committee and the full Senate have agreed with this position through passage of SB 235. Olathe supports HB 2208 because it is consistent with the city's position that STAR bond authority should be expanded beyond current law for significant projects as determined by the Secretary of Commerce.

To date, STAR bonds have been utilized in connection with the highly successful Kansas Speedway and related development in western Wyandotte County. This project has been a tremendous economic stimulus for both Wyandotte County and the state of Kansas. The project envisioned by Wichita interests also has potential to be a great success. However, as the committee recently heard from Olathe officials, there are other areas of the state where projects of statewide significance are being considered.

This committee is especially mindful of the need to encourage growth of the Kansas economy to help the state emerge from its current fiscal situation. Projects of statewide significance may not occur every day, but they can play a powerful role in growing our state's economy. Under either this bill or SB 235, STAR bond projects will still meet standards established by the Legislature and the Department of Commerce that define statewide significance. STAR bond projects will bring in new dollars and revenue from outside the state.
