SUBJECT: Fiscal Note for SB 2 by Senate Confirmation Oversight Committee

In accordance with KSA 75-3715a, the following fiscal note concerning SB 2 is respectfully submitted to your committee.

SB 2 would amend current law regarding terms of members on the Kansas Agricultural Remediation Board and the University of Kansas Hospital Authority. First, the bill states that terms of those serving on the Agricultural Remediation Board will expire on March 15 of the year in which the members' terms would have expired under their current appointments. Second, the bill makes technical conforming amendments to current law on appointments to the KU Hospital Authority.

The bill would have no fiscal effect on the Kansas Department of Agriculture or the University of Kansas Medical Center or Hospital.
