## Confirmation Hearing for Member of the State Board of Indigents' Defense Services

Chairman Vratil opened the confirmation hearing for Denise E. Tomasic's reappointment by the Governor as a member of the State Board of Indigents' Defense Services. The Committee members were furnished with copies of information regarding the confirmation for their information and perusal. (Attachment 1) Chairman Vratil asked Ms. Tomasic to comment about her experience of serving on the Board of Indigents' Defense Services.
