Chairman Myers introduced the new committee member Representative Oletha Faust-Goudeau from Wichita. She is replacing now-Senator Donald Betts.

The order of business was the request for bills. Committee Chairman Don Myers requested a bill on campaign finance. The bill would clarify the transfer of a candidate's campaign funds from one office to another.

Representative McLeland moved and Representative McCreary seconded the motion that such a bill be introduced. The motion carried.

Brad Bryant, Deputy Assistant Secretary of State, appeared before the committee to request 2 bills. The first would be a bill regarding advanced voting. It would require the county election officer to check the signatures on the envelopes of advanced voting ballots returned by mail and challenge ballots if the signatures do not match the registration records. Also, it would require a person assisting a sick, physically disabled or illiterate voter to specify the reason the voter needs assistance and require that the person assisting the voter file an affidavit of assistance. The second bill would allow counties' election abstracts to be filed with the Secretary of State by secure electronic transmission. (Attachment 1)

Representative Huebert moved that these two bills be introduced. Representative Siegfreid seconded the motion. The motion passed.

Mr. Chairman and Members of the Committee:

The Secretary of State requests introduction of two committee bills.

1. Advance voting bill—

This bill would accomplish two things:

- a. It would require the county election officer to check the signatures on the envelopes of advance ballots returned by mail and challenge ballots if the signatures do not match the registration records.
- b. It would require a person assisting a sick, physically disabled or illiterate voter to specify the reason the voter needs assistance when the person files an affidavit of assistance.
- 2. Electronic election abstract bill—
 This bill would allow counties' election abstracts to be filed with the Secretary of State by secure electronic transmission.
