HB 2707: Designating part of K-4 highway as the Masie DeVore highway

Representative Burgess, 51st District, testified in support of this bill on behalf of one of his constituents, Masie DeVore. Hers is a well publicized story, and she serves as a reminded to all, of the difference one person can make. It seems only fitting to have her name on a portion of the highway she walked for more than 30 years, collecting aluminum cans, in order to build a swimming pool for the children in her small home town (Attachment 1). Also in support of this bill, Deann Williams, DeVore Community Swimming Pool Association described other activities undertaken by Masie DeVore to earn moneys for her project to be built. Masie DeVore continues to work at all of her fund raising projects in order to support the continued operation and maintenance of the pool. No tax dollars are received for this. She won the Jefferson Award for the State of Kansas, traveled to Washington, D.C. and was one of five national winners of the Jacqueline Kennedy Onassis awards for public service in 2002 (Attachment 2). She introduced Ms. DeVore to all present. Laura Kelly, Executive Director, Kansas Recreation and Park Association was unable to attend. She provided written testimony in "enthusiastic support" of this bill (Attachment 3). Senator Jim Barnett, 17th District, also provided written testimony in support (Attachment 4). Chairman Donovan asked Ms. DeVore for her comments. She advised that when she was about halfway to her goal in raising funds, the Eskridge City Council informed her that they did not intend to provide funding for operation and maintenance of a swimming pool and that is why she continues her fund raising efforts to this day. Hearing closed.

HB 2623: Designating part of K-20 highway as the Kickapoo Veterans Memorial highway

Steve Cadue, Tribal Chairman, Kickapoo Tribe in Kansas spoke in support of this bill. He provided historical information on the Kickapoo Veterans. They see this designation as a way to show travelers the Kickapoo people's respect for and love of this country (<u>Attachment 5</u>). Dale White, Mayor, City of Horton, Kansas, speaking in support of the bill, stressed the positive effects that he feels would result from passage of this bill (<u>Attachment 6</u>). Representative Larkin, District 62, did not have written testimony, but had testified in support of the bill on the House side. He reported that statistics presented to the House included the fact that 70% of the male tribal members have served in the U.S. armed forces and he urged the Senate pass this bill. No other conferees were present. Hearing closed.

<u>HB 2136:</u> <u>Designating a portion of U. S. Highway 400 as the 930th Ordnance Ammunition Company Bypass</u>

Representative Jeff Jack, District 7, speaking in support of the bill provide historical background and

information regarding this Reserve unit's impact on the community and the sacrifices made by these men. Furthermore, they see implementation of this bill as a way to show support to troops who are once again serving overseas (Attachment 7). Representative Jack introduced some members of the 930th Ordnance Ammunition Company who traveled to Topeka for this hearing today; Charley Chenoweth, Ray King, Manual Bayless, and Gerald Bowman. Mr. Bowman's son was also present. In the general discussion that followed their introduction, the unit members stressed how very much they would like to have this bill passed. Representative Jack pointed out there are letters of support from the Board of Commissioners, Labette County, Kansas (Attachment 8); and Mayor Westervelt, City of Parsons, Kansas (Attachment 9). Hearing closed.

Staff explained one more proposed amendment to be included in a highway designation bill. It deals with what is now called the "Hutchinson by-pass", or the new K-96 alignment, which would be named the Senator Bob Dole by-pass. It has the current reimbursement language plus the additional 50% language to defray future maintenance and replacement costs of such signs. An example of the expiration clause is shown in Section (b), if the committee wishes to include it. Members discussed this sunset clause and decided not to include it in this amendment. Senator Schodorf moved to recommend Section (a) only be include in an overall highway designation bill. Senator Salmans seconded the motion. Motion carried. Following further discussion, Senator Salmans moved to amend the 50% language into all the highway designation bills. Senator Schodorf seconded the motion. Motion carried. Members discussed the highway designation bills. In order to simplify the legislative process, it was decided that HB 2833 would be an appropriate vehicle for all of these bills because it amends a particular section of KSA. The Divisions discussed in this bill are now reserve divisions, but some of them go back to World War I era. Senator Salmans moved to amend HB 2707, HB 2623, HB-2136 and the additional amendment on the Senator Bob Dole by-pass designation into HB 2833. Senator Goodwin moved to recommend HB 2833, as amended, favorable for passage. Senator Schodorf seconded the motion. Motion carried.

HB 2143: Distinctive license plates, regulations

Hearings were held on this bill March 11, 2004. At that time the essential language of **SB 68**, regarding helping schools special plates, was amended into it. Also passed a technical amendment striking the use of signs and punctuation marks on personalized plates. Senator Pugh proposed an additional amendment, which really came from the House side, to add a new section to present K.S.A. regulating distinctive license plates that would allow bronze or silver star recipients who are residents of the State of Kansas to be issued distinctive license plates. All the usual rules and regulations dealing with veterans plates would be applicable in these instances. Discussion revealed that surviving family can keep the plates, but not display them on a vehicle. Senator Pugh moved adoption of this amendment. Senator Goodwin seconded the motion. Motion carried. Senator Jackson moved to recommend **HB 2143**, as amended, favorable for passage. Senator Schodorf seconded the motion. Motion carried. Senator Pugh will carry the bill.

HB 2235: Sun screening devices, decals, exception

Hearings on this bill were held March 11, 2004. Members felt there were many problems needing to be resolved before this bill could become effective law. It is perfectly understandable why the Highway Patrol desires it for the safety and well being of their canine partners. However, it needs more work before being enacted into law. Senator Salmans moved to recommend HB 2235 be not passed. Senator Lyon seconded the motion. Motion carried.

HB 2709: Regulating traffic, motorized skateboards

Hearings were held on this bill March 16, 2004. It attempts to define motorized skate boards. It is really a much bigger issue than just skateboards. More and more of these motorized "toys" are showing up. At some point we probably need to deal with the entire area rather than passing one law at a time when an obvious problem comes up. The committee took no action on this bill.

The meeting adjourned at 9:25 a.m. No more meeting are scheduled for this session.

I am Deann Williams from Eskridge appearing before you today on behalf of the DeVore Community Swimming Pool Association in support of House Bill 2707.

Maisie DeVore, founder of Maisie's Community Swimming Pool in Eskridge has demonstrated the integrity and sheer determination to make a dream become reality. For more than 30 years and raising \$100,000 Maisie collected aluminum cans (many along K4 highway), she made afghans, jams, jellies, had numerous bake sales and rummage sales with all proceeds going toward the swimming pool project.

In January of 2001 a \$73,000 Parks and Wildlife local government grant was received by the city of Eskridge. So with Maisie's portion and the grant the pool project began. Maisie's Community Swimming Pool opened July 14, 2001.

Maisie continues her aluminum can collection regiment weekly and is eager to help with any other fundraising efforts in order for the pool to be a success, as no tax dollars are received for operating expenses.

After Maisie's success with the swimming pool she was nominated and won the Jefferson award in Kansas. Therefore, Maisie had the opportunity to travel to Washington, DC and was named as one of five national award winners of the Jacqueline Kennedy Onassis award program for public service in 2002.



Chairman Donovan and Members of the Senate Committee on Transportation; I thank you for the opportunity to speak to you today in favor of HB-2623 designating a portion of K-20 between Highway 75 and Horton, KS as the **Kickapoo Veteran's Memorial Highway.** This request while modest is one that will have important positive effects in years to come. As Mayor of Horton and friend to the Kickapoo tribe in Kansas I would like to briefly review my thoughts on this matter with you.

The Kickapoo are celebrating their 150th year here in Kansas. They are a proud and honorable people who it has been my good fortune to get to know over the last 9 years. We have worked closely together over my short time as Mayor to improve relations between our communities. I have learned much from them and I hope they from me. Despite being neighbors for more than 100 years I was surprised at the figurative distance there was between our communities. I like to say that Chairman Cadue and I are working to shorten the distance of the highway between the reservation and Horton. One thing I have learned through this process is that we need to take time to recognize and honor the accomplishment and contributions that have been made. As I have said the proposal before you is in and of itself a modest request but if we think about what it means I feel sure you will agree that it is one of the most important things you can accomplish this session. Native Americans have served this country from it inception in and for our military. They have guided and fought and died on behalf of our Nation in the past and on to today. There is no greater gift that one can give then their service to their country. If we do not remember a gift then it loses its value over time and becomes worthless. As Christ said "what good is salt if it losses it's saltiness?" The simple act of the designation and placement of signs proclaiming to the world that we remember and appreciate the sacrifices of those on our behalf; by members of the Kickapoo Tribe we are assuring that the salt remains tasty and fully worth its value. Those who pass through the reservation will if only for a brief moment think of the contribution of these fine individuals. The Elders of the tribe will see the signs and know that they are remembered and appreciated. The young adults will look and see that their efforts to contribute to the good of the community and nation will not go unnoticed. The children will see and believe that there dreams can come true. Today our children need good examples.

So: remembrance and appreciation, recognition and hope, and finally honor, all for the cost of a few signs. Not a bad return on investment. And in some small way you will also help shorten the highway between the Kickapoo reservation and the rest of the county.

I thank you for your time and consideration in this matter.

Testimony regarding HB 2136

18 March 2004

On August 14, 1950, over two hundred men of the 930th Ordnance Ammunition Company, United States Army Reserve, Parsons, Kansas was activated for federal service in the Korean conflict. Most of the men were from Parsons and Labette County, and all but 18 of these men had previously heard the call and had served in World War II. The unit was sent to Korea in January, 1951, where it performed its hazardous logistics mission honorably and well, spending over a year in country.

Over fifty years have passed. I am here today in support of HB 2136, which would name the new US Highway 400 by-pass around Parsons the 930th Ordnance Ammunition Company by-pass. I believe this is a small gesture to recognize the large sacrifice these men made in leaving their homes and families in service to their country.

By memorializing this unit, we do not mean to exclude all veterans of all wars who have served; instead, we are simply recognizing the significant impact this unit and their mobilization and service had not just on the members of the unit, but on the entire community.

In December I attended the farewell ceremony for another Army Reserve unit from Parsons. Once again, our soldiers are being sent to serve their country in a dangerous place far from home. I can think of no better way to show our support to these troops than to promise them that we will never forget their sacrifice, by showing that we remember and cherish the sacrifice of those who have gone before them.
